**PROCLAMATION**

BY HIS HONOUR ALBERTUS JOHANNES WERTH, ADMINISTRATOR OF SOUTH WEST AFRICA.

No. 27 of 1929.]

WHEREAS it is desirable to make better provision for the government of Ovamboland;

NOW THEREFORE, under and by virtue of the powers in me vested, I do hereby proclaim, declare and make known as follows:—

1. The area defined as the Magisterial District of Ovamboland by the Second Schedule to Proclamation of the Administrator dated the second day of September, 1920 (Proclamation No. 40 of 1920), and hereinafter referred to as "Ovamboland", is hereby set apart as a reserve for the sole use and occupation of natives.

Ovamboland constituted a native reserve.

Regulations.

2. (1) The Administrator may make regulations for the government of Ovamboland.

(2) Any person contravening or failing to comply with any regulation made under the provisions of this section, or with any order issued under the authority of any such regulation, shall be guilty of an offence and liable to the penalties prescribed in the regulations for such contravention or default, and if no specific penalty is prescribed for any such contravention or default, the court convicting him may impose upon him a fine not exceeding twenty-five pounds, or, in default of payment, imprisonment, with or without hard labour, for a period not exceeding six months.

(3) Any such regulations may be made applicable only to any particular areas or in respect only of particular classes of persons or tribes or portions of tribes, and different regulations may be made for different areas or in respect of different classes or tribes or portions of tribes.

Establishment of Trust Funds.

3. (1) The Administrator may by notice published in the *Gazette* establish for any tribe or aggregate of tribes or portion of a tribe a separate Trust Fund.

(2) There shall be paid into any Fund so established all moneys received by the Administration under any rate, tax, levy, fee or charge imposed upon the members of any tribe or aggregate of tribes or portion of a tribe for which the Fund is established, all moneys specially donated to such Fund, and, if the Administrator so direct, any moneys due to such tribe or aggregate of tribes or portion of a tribe from any source.

(3) If at any time it appear to him expedient, the Administrator may—

- (a) in case of the union of any tribes or portions of tribes for which separate Funds have been established, order that those Funds be joined to form a single Fund; or
- (b) in case of the sub-division of any tribe or aggregate of tribes or portion of a tribe for which a separate Fund has been established order that that Fund be sub-divided, in such manner and in such proportions as may be directed by him, into two or more separate Funds to be allocated to the sub-divisions of such tribe or aggregate of tribes or portion of a tribe.

(4) The moneys contained in any Fund shall be expended as directed by the Administrator, after consultation with the chief or chiefs or, if there be no chief, with the headmen of the tribe or aggregate of tribes or portion of a tribe for which the Fund has been established, upon objects which in the opinion of the Administrator are in the interest and calculated to promote the welfare of that tribe or aggregate of tribes or portion of a tribe.

(5) Proper accounts shall be kept by the Accounting Officer of South West Africa of all receipts and expenditure in connection with every Fund.

(6) The Administrator may levy an annual rate upon the members of every tribe or aggregate of tribes or portion of a tribe for which a Fund has been established.

(7) The rate shall be of such amount not exceeding twenty shillings as the Administrator may from time to time determine.

(8) Notice of the levy of a rate shall be given in the *Gazette* and in such other manner as the Administrator may direct and the notice shall fix the date upon which the rate falls due.

**PROKLAMASIE**

NADEMAAL dit wenslik is om beter voorsiening vir die regering van Ovamboland te maak;

SO IS DIT dat ek, op grond van en kragtens die bevoegdhede aan my verleen, hiermee proklameer, verklaar en bekend maak, as volg:—

1. Die landstreek wat as die magistraatsdistrik Ovamboland bepaal is deur die Tweede Bylae tot die Proklamasie van die Administrateur, gedateer die tweede dag van September 1920, (Proklamasie No. 40 van 1920), en hierin later "Ovamboland" genoem, word hiermee uitgehou as 'n reservaat vir uitsluitelike gebruik en bewoning deur naturele

Ovamboland tot naturelle-reservaat verklaar.

2. (1) Die Administrateur kan regulasies vir die regering van Ovamboland maak.

(2) Enige persoon wat enige regulasie, kragtens die bepalings van hierdie artikel gemaak, oortree of nienakomnie, of enige order, op grond van enige sodanige regulasies uitgevaardig, nienakomnie, is skuldig aan 'n oortreding en strafbaar met die strawwe, in die regulasies vir sodanige oortreding of nie-nakoming voorgeskryf, en indien geen bepaalde straf vir sodanige oortreding of nie-nakoming voorgeskryf is nie, dan kan die hof, wat hom skuldig bevind, hom 'n boete ople van nie meer as vyf-en-twintig pond nie, of, by wanbetaling, tronkstraf, met of sonder dwangarbeid, vir 'n tydperk van nie langer as ses maande nie.

(3) Enige sodanige regulasies kan toepaslik gemaak word op enige besondere streke alleen, of ten aansien van alleen besondere klasse van persone of stamme of gedeeltes van stamme, en verskillende regulasies kan gemaak word vir verskillende streke of ten aansien van verskillende klasse of stamme of gedeeltes van stamme.

3. (1) Die Administrateur kan, deur kennisgewing in die *Offisiële Koerant* gepubliseer, vir enige stam of aggregaat van stamme of 'n gedeelte van 'n stam 'n afsonderlike trustfonds stig.

(2) In enige fonds, sodanig gestig, word gestort alle geldie deur die Administrasie ontvang ingevolge enige belasting, heffing, fooi of las opgelê op die lede van enige stam of aggregaat van stamme of gedeelte van 'n stam waarvoor die fonds gestig is, alle geldie spesiaal aan sc danige fonds geskenk, en, indien die Administrateur dit geskeen, alle geldie van enige bron aan sodanige stam of aggregaat van stamme of gedeelte van 'n stam verskuldig.

(3) Indien dit hom te enige tyd dienstig skyn kan :

Administrateur—

(a) ingeval van die vereniging van enige stamme of gedeeltes van stamme, waarvoor afsonderlike fondse gestig is, gelas dat die fondse verenig word om een enkele fonds te vorm; of

(b) ingeval van die onderverdeling van enige stam of aggregaat van stamme of gedeelte van 'n stam, waarvoor 'n afsonderlike fonds gestig is, gelas dat die fonds onderverdeel word, op sodanige wyse en in sodanige verhouding as hy mag voorskryf, in twee of meer afsonderlike fondse, om toegewys te word aan die onderverdelings van sodanige stam of aggregaat van stamme of gedeelte van 'n stam.

(4) Die geldie, in enige fonds vervat, moet bestee word soos deur die Administrateur voorgeskryf, na raadpleging van die Kaptein of Kapteins, of, as daar geen Kaptein is nie, van die hoofmanne van die stam of aggregaat van stamme of gedeelte van 'n stam, waarvoor die fonds gestig is, vir doelendes wat volgens die mening van die Administrateur in die belang van daardie stam of aggregaat van stamme of gedeelte van 'n stam is, en bereken om die welvaart daarvan te bevorder.

(5) Behoorlike boek word gehou deur die Rekenpligtige Beampye van Suidwes-Afrika van alle inkomste en uitgawe in verband met iedere fonds.

(6) Die Administrateur kan 'n jaarlike belasting hef op die lede van elke stam of aggregaat van stamme of gedeelte van 'n stam, waarvoor 'n fonds gestig is.

(7) Die belasting is sodanige bedrag, van nie meer as twintig sielings nie, as wat die Administrateur van tyd tot tyd mag vasstel.

(8) Kennis van die heffing van 'n belasting word in die *Offisiële Koerant* gegee en op sodanige ander wyse as wat die Administrateur mag gelas, en die kennisgewing moet die datum, waarop die belasting betaalbaar is, bepaal.

(9) The rate shall be payable to the officer of the Administration appointed to exercise authority over the tribe or aggregate of tribes or portion of a tribe for which the Fund has been established, and shall be paid into the Fund.

(10) All male persons of the apparent age of eighteen years who are members of the tribe or aggregate of tribes or portion of a tribe, and who have not been exempted from payment under the next succeeding sub-section, shall be liable to pay the rate, whether or not they are at the time in Ovamboland, and any male person who leaves Ovamboland for the purpose of taking up or seeking work shall be deemed to be not less than eighteen years of age.

(11) Any person who is indigent and is prevented from working by reason of age, infirmity, chronic disease or other sufficient cause may be exempted from payment of the rate by the officer appointed to exercise authority over the tribe, aggregate of tribes or portion of a tribe to which that person belongs, and in the case of a person residing or being for the time being outside of Ovamboland, by the Officer-in-Charge of Native Affairs or other officer having authority at the place where that native resides or for the time being is.

(12) Any person who fails to pay the rate due by him within sixty days from the date upon which the rate became due shall be guilty of an offence and liable on conviction to a fine not exceeding five pounds or, in default of payment, to imprisonment, with or without hard labour, for a period not exceeding one month.

The court shall on passing sentence also give judgment for the amount of the rate in default, which judgment shall be executable in all respects as if it were a civil judgment of the court.

4. (1) The Senior Officer of the Administration in Ovamboland, may, subject to the instructions of the Secretary for South West Africa, enrol fit and proper persons, who shall be natives, as constables of a body to be entitled the Ovamboland Police, and at any time and for any reason or without assigning any reason and without notice suspend, reduce, discharge or dismiss any such person from such body.

(2) Every constable of the Ovamboland Police shall be engaged on a written contract of service setting forth the conditions of his employment.

(3) Every constable of the Ovamboland Police shall on enrolment take the following oath:—

"I, ..... do swear that I will faithfully serve the Administrator of South West Africa in the Ovamboland Police.

So help me God."

(4) The Secretary for South West Africa may appoint any officer of the Administration in Ovamboland to be a member and officer of the Ovamboland Police and the Senior Officer in Ovamboland shall command that body.

Every officer so appointed shall, subject to the directions of the Senior Officer, superintend and control such constables thereof as may be placed under their charge.

(5) Every member of the Ovamboland Police shall exercise and perform in Ovamboland all the powers, duties and functions which under any law are exercised and performed by members of the South West Africa Police.

(6) Any constable of the Ovamboland Police who commits any act or makes any default, the commission, or making of which by a member of the South West Africa Police would be an offence, shall be guilty of an offence and liable on conviction to a fine not exceeding twenty-five pounds, or in default of payment, to imprisonment, with or without hard labour, for a period not exceeding six months.

5. Nothing in this Proclamation contained shall in any way affect the application in Ovamboland of any law in force in Ovamboland at the date of the commencement of this Proclamation.

6. This Proclamation may be cited for all purposes as the Ovamboland Affairs Proclamation, 1929.

(9) Die belasting is betaalbaar aan die beampete van die Administrasie wat aangestel is om gesag uit te oefen oor die stam of aggregaat van stamme of gedeelte van 'n stam, waaroor die fonds gevestig is, en word in die fonds gestort.

(10) Alle manspersone van die skynbare ouderdom van agtien jaar wat lede is van die stam of aggregaat van stamme of gedeelte van 'n stam, en wat nie ingevolge die naasvolgende onderartikel van betaling vrygestel is nie, is aan betaling van die belasting onderhewig, of hulle dan in Ovamboland is of nie, en enige manspersoon wat Ovamboland verlaat met die doel om werk aan te neem of te soek sal beskou word nie minder as agtien jaar oud te wees.

(11) Enige persoon wat behoeftig is en verhinder is om te werk deur ouderdom, gebreklikeheid, kroniese siekte of ander voldoende rede kan deur die beampete, aangestel ongesag uit te oefen oor die stam, aggregaat van stamme of gedeelte van 'n stam waaraan daardie persoon behoort, vrygestel word van betaling van die belasting, en ingeval van 'n persoon wat vir die oomblik buitekant Ovamboland woon, deur die Beampete met Naturellesake belas of 'n ander beampete met gesag op die plek waar daardie naturel woon of hom vir die oomblik bevind.

(12) Enige persoon wat versuim om die belasting, deur hom verskuldig, binne sestig dae vanaf die datum waarop die belasting betaalbaar was, te betaal, is skuldig aan 'n oortreding en by skuldigbevinding strafbaar met 'n boete van hoogstens vyf pond, of, by wanbetaling, tot tronkstraf, met of sonder dwangarbeid, vir 'n tydperk van nie langer as een maand nie.

By vonnissing gee die hof ook uitspraak vir die bedrag van die agterstallige belasting, watter uitspraak in alle opsigte uitvoerbaar is asof dit 'n burgerlike uitspraak van die hof was.

4. (1) Die senior beampete van die Administrasie in Ovamboland kan, onderworpe aan die voorskrifte van die Sekretaris vir Suidwes-Afrika, gesikte en behoorlike persone, wat naturel moet wees, aanwerf as konstabels in 'n liggaam, wat die Ovambolandse Poliesie genoem word, en te enige tyd en sonder enige rede te gee en sonder kennisgewing enige sodanige persoon skors, degradeer, of uit sodanige liggaam afdank of ontslaan.

(2) Iedere konstabel van die Ovambolandse Poliesie word aangewerf op 'n skriftelike dienskontrak wat die voorwaarde van sy indiensneming uiteensit.

(3) Iedere konstabel van die Ovambolandse Poliesie neem by aanwerwing die volgende eed:—

"Ek ..... sweer dat ek die Administrateur van Suidwes-Afrika getrou in die Ovambolandse Poliesie sal dien.

So help my God."

(4) Die Sekretaris vir Suidwes-Afrika kan enige beampete van die Administrasie in Ovamboland benoem as lid en offisier van die Ovambolandse Poliesie, en die senior beampete van Ovamboland voer bevel oor daardie liggaam.

Iedere offisier, aldus benoem, hou toesig oor en kontroleer, onderworpe aan die bevele van die senior beampete, sodanige konstabels daarvan as wat onder sy toesig geplaas mag word.

(5) Elke lid van die Ovambolandse Poliesie oefen in Ovamboland al die bevoegdhede, pligte en werksaamhede uit wat volgens enige wet deur iede van die Suidwes-Afrikaanse Poliesie uitgeoefen word.

(6) Enige konstabel van die Ovambolandse Poliesie wat 'n daad begaan of nalaat, waarvan die begaan of nalating deur 'n lid van die Suidwes-Afrikaanse Poliesie 'n oortreding sou wees, is skuldig aan 'n oortreding en by skuldigbevinding strafbaar met boete van hoogstens vyf-en-twintig pond, of, by wanbetaling, met tronkstraf, met of sonder dwangarbeid, vir 'n tydperk van nie meer as ses maande nie.

5. Niks in hierdie Proklamasie vervat raak op enige wyse die toepassing in Ovamboland nie van enige wet, in Ovamboland van krag op die datum van die inwerkingtreding van hierdie Proklamasie.

6. Hierdie Proklamasie kan vir alle doeleindes aangehaal word as die Ovambolandse Aangeleenthede Proklamasie 1929.
