1. In hierdie Proklamasie beteken die uitdrukking "die Hoofproklamasie" "De Politie Proklamatie, 1921" (Proklamasie No. 56 van 1921), soos gewysig deur "De Politie (Wijziging) Proklamatie 1922" (Proklamasie No. 24 van 1922), "De Politie Proklamatie Verdere Wijzigingsproklamatie, 1924" (Proklamasie No. 1 van 1924), en die Poliesie Proklamasie-Wysigingsproklamasie 1927 (Proklamasie No. 34 van 1927).

2. Artikel *agt* van die Hoofproklamasie word hierby gewysig deur die skraping van die voorbehoud daarvan.

Under and by virtue of the powers in me vested by Act No. 49 of 1919 and Act No. 20 of 1922, I do hereby declare, proclaim and make known that the Railways and Harbours Service and Superannuation Funds Acts Amendment Act No. 19 of 1931 and the Railways and Harbours Regulation, Control and Management (Further Amendment) Act No. 21 of 1931, shall *mutatis mutandis* as far as capable of application have force and effect within the Mandated Territory of South West Africa with effect from the dates on which the respective Acts came into force within the Union of South Africa.

**PROCLAMATIONS**

BY HIS HONOUR ALBERTUS JOHANNES WERTH, ADMINISTRATOR OF SOUTH WEST AFRICA.

No. 42 of 1931.]

WHEREAS it is desirable further to amend Proclamation of the Administrator of South West Africa dated the first day of December, 1921, entitled the Police Proclamation, 1921;

NOW THEREFORE, under and by virtue of the powers in me vested, I do hereby proclaim, declare and make known as follows:—

1. In this Proclamation the expression "the principal Proclamation" means the Police Proclamation, 1921 (Proclamation No. 56 of 1921), as amended by the Police (Amendment) Proclamation, 1922 (Proclamation No. 24 of 1922), the Police Proclamation Further Amendment Proclamation, 1924 (Proclamation No. 1 of 1924), and the Police Proclamation Amendment Proclamation, 1927 (Proclamation No. 34 of 1927).

2. Section *eight* of the principal Proclamation is hereby amended by the deletion of the proviso thereto.

3. This Proclamation may be cited for all purposes as the Police Proclamation Amendment Proclamation, 1931, and shall be deemed to have commenced and come into operation on the first day of April, 1931.

### TOWNSHIPS REGULATIONS.

The Administrator has been pleased, under and by virtue of the powers in him vested by Section *thirty-five* of the Townships Ordinance, 1928 (Ordinance No. 11 of 1928), to make the following regulations:—

#### REGULATIONS.

1. In these regulations "the Board" means the Townships Board constituted under Section *four* of the Townships Ordinance, 1928 (Ordinance No. 11 of 1928), as amended by Section *two* of the Townships Ordinance Amendment Ordinance, 1931 (Ordinance No. 14 of 1931), and "the chairman" means the chairman of the Board.

2. The Board shall as far as possible meet within the first half of each and every calendar month. At least seven days' notice shall be given to members of the Board of the place, date and hour of the meeting and the nature of the business to be transacted at such meeting.

3. The chairman shall call a special meeting of the Board whenever he deems it necessary or expedient to do so, and he shall do so if required thereto in writing by any three members of the Board, provided that at least twenty-four hours' notice of such special meeting shall be given.

4. A record shall be kept of all resolutions of the Board, and such record shall, together with such plans and diagrams as the chairman may direct, be bound in book form at the end of each calendar year.

5. Subject to the provisions of regulation 6, four members, including the chairman, shall form a quorum at any meeting of the Board.

6. If by reason of a quorum not being present it becomes necessary for the chairman to call a second meeting in respect of the same business, and if within half an hour from the time appointed for such meeting a quorum is not present, any two members present at such meeting, including the chairman, shall form a quorum.

7. At all meetings of the board the chairman shall have a deliberative as well as a casting vote.
