No. 2, 1935 (Union).]

ACT

To amend the Medical, Dental and Pharmacy Act, 1928.

BE IT ENACTED by the King's Most Excellent Majesty, the Senate and House of Assembly of the Union of South Africa, as follows:—

1. Section *seven* of the Medical, Dental and Pharmacy Act, 1928 (hereinafter referred to as the principal Act), is hereby amended by the deletion of all words after the word "but" and the substitution therefor of the words: "no penalty imposed by any such committee other than a caution or a reprimand, or a reprimand and a caution shall be of force and effect until the council or board has confirmed its imposition".

2. Section *thirteen* of the principal Act is hereby repealed and the following new section *thirteen* substituted:

"Amendment of First Schedule. 13. The Governor-General may from time to time by regulation amend the First Schedule to this Act".

3. Section *twenty-two* of the principal Act is hereby amended by the insertion after the word "druggists" where it occurs for the first time, of the words "if they have, before or in connection with or after the acquisition of those degrees, diplomas or certificates, complied with such conditions or requirements as may be prescribed in any such regulation".

4. Sub-section (3) of section *twenty-three* of the principal Act is hereby amended by the insertion after the words "(as the case may be)" where they occur for the first time, of the words "if he has, before or in connection with or after the acquisition of any such degree, diploma or certificate, complied with such conditions or requirements as may be prescribed in any such regulation".

5. Sub-section (2) of section *twenty-eight* of the principal Act is hereby amended by the insertion after the word "druggist" where it occurs for the first time, of the words "if he has, before or in connection with or after the acquisition of any such diploma or certificate, complied with such conditions or requirements as may be prescribed in any such regulation".

6. Paragraph (a) of sub-section (1) of section *forty-two* of the principal Act is hereby deleted and the following paragraph substituted therefor:

"(a) a caution or a reprimand or a reprimand and a caution".

7. Sub-section (1) of section *ninety-nine* of the principal Act is hereby amended by the insertion, after the words "purposes of this Act" of the words "except for the purposes of paragraph (b) of the proviso to sub-section (4) of section *two*".

8. This Act shall be known as the Medical, Dental and Pharmacy Amendment Act, 1935.

PROCLAMATION

WHEREAS it is expedient to amend the law relating to the protection of the diamond industry;

NOW THEREFORE, under and by virtue of the powers in me vested, I do hereby proclaim, declare and make known as follows:—

WET

Tot wysiging van die Wet op Geneeshere, Tandartse en Aptekers, 1928.

DIT WORD BEPAAL deur Sy Majesteit die Koning, die Senaat en die Volksraad van die Unie van Suid-Afrika, as volg:—

1. Artikel *sewe* van die Wet op Geneeshere, Tandartse en Aptekers, 1928 (hieronder die Hoofwet genoem), word hiermee gewysig deur alle woorde na die woord „maar” te skrap en te vervang deur die woorde „geen straf deur so ’n komitee opgelê (behalwe ’n waarskuwing of ’n berisping of ’n berisping en ’n waarskuwing) is regsgeldig nie totdat die raad of kommissie die oplegging daarvan bekragtig het”.

2. Artikel *dertien* van die Hoofwet word hiermee herroep en deur die volgende artikel vervang:

„Wysiging van Eerste Bylae. 13. Die Goewerneur-generaal kan van tyd tot tyd die Eerste Bylae tot hierdie Wet deur regulasies wysig”.

3. Artikel *twee-en-twintig* van die Hoofwet word hiermee gewysig deur die volgende woorde na die woord „aptekers”, waar dit vir die eerste keer voorkom, in te voeg: „mits hulle voor of in verband met of na die verkryging van daardie grade, diplomas of sertifikate voldoen het aan die voorwaardes of vereistes wat so ’n regulasie mag voorskryf”.

4. Sub-artikel (3) van artikel *drie-en-twintig* van die Hoofwet word hiermee gewysig deur die volgende woorde na die woorde „geregistreer te word” in te voeg: „mits hy voor of in verband met of na die verkryging van so ’n graad, diploma of sertifikaat voldoen het aan die voorwaardes of vereistes wat so ’n regulasie mag voorskryf”.

5. Sub-artikel (2) van artikel *agt-en-twintig* van die Hoofwet word hiermee gewysig deur die volgende woorde na die woorde „geregistreer te word” in te voeg: „as hy voor of in verband met of na die verkryging van so ’n diploma of sertifikaat voldoen het aan die voorwaardes of vereistes wat so ’n regulasie mag voorskryf”.

6. Paragraaf (a) van sub-artikel (1) van artikel *twee-en-veertig* van die Hoofwet word hiermee geskrap en deur die volgende paragraaf vervang:

„(a) ’n waarskuwing of ’n berisping of ’n berisping en ’n waarskuwing of”.

7. Sub-artikel (1) van artikel *negen-en-negentig* van die Hoofwet word hiermee gewysig deur die volgende woorde na die woorde „doeleindes van hierdie Wet” in te voeg: „behalwe vir die doeleindes van paragraaf (b) van die voorbehoudsbepaling tot sub-artikel (4) van artikel *twee*”.

8. Hierdie Wet heet die Wysigingswet op Geneeshere, Tandartse en Aptekers, 1935.

PROKLAMASIE

VAN SY EDELE DAVID GIDEON CONRADIE,

NADEMAAL dit wenslik is om die Wet met betrekking tot die beskerming van die diamant-industrie te wysig;

SO IS DIT dat ek, onder en kragtens die bevoegdhede aan my verleen, hierby proklameer, verklaar en bekend maak, as volg:—

1. Section *seventeen* of the Diamond Industry Protection Proclamation, 1922 (Proclamation No. 26 of 1922), is hereby amended by the addition of the following sub-section, the present section being regarded as sub-section (1):—

“(2) It is provided furthermore that where diamonds which are the property or in the lawful possession of the said Board are utilised with the concurrence of the said Board, by the Diamond Detective Department or by the South West Africa Police in the pursuance of their duties, and cannot be recovered, the proceeds of such diamonds shall be the property of the said Board.

When such diamonds utilised as aforesaid are recovered, the said diamonds shall be restored to the said Board, and the proceeds thereof shall be contributed towards payment of the expenses of the said Board.”

2. This Proclamation may be cited for all purposes as the Diamond Industry Protection Proclamation Amendment Proclamation, 1935.

“(2) Verder word voorziening gemaakt dat wanneer diamanten welke het eigendom of in het wettiglijk bezit van de gezegde Raad zijn, gebruikt worden met de toestemming van de gezegde Raad, door de Diamant Politie Departement of door de Zuidwest-Afrika Politie in de uitoefening van hulle plichten, en niet weder teruggekrijgt kunnen worden, dan zal de opbrengst van zodanige diamanten het eigendom van de gezegde Raad zijn.

Wanneer zulke diamanten welke als bovengemeld gebruikt zijn, teruggekrijgt worden, dan zullen de gezegde diamanten aan de gezegde Raad teruggegeven worden, en de opbrengst ervan zal besteden worden voor de betaling van de onkosten van de gezegde Raad.”

2. Hierdie Proklamasie kan vir alle doeleindes as die Diamant-industrie Beskermingsproklamasie Wysigingsproklamasie, 1935, aangehaal word.

3. Advertisements will be inserted in the *Gazette* after the official matter or in a supplement to the *Gazette* at the discretion of the Secretary.
