PROCLAMATION

BY HIS HONOUR FRANCIS PRIESTLEY COURTNEY CLARKE, DEPUTY ADMINISTRATOR OF SOUTH WEST AFRICA.

No. 10 of 1935.]

WHEREAS it is desirable further to amend Proclamation of the Administrator of South West Africa dated the first day of December, 1921, entitled "The Police Proclamation, 1921";

NOW THEREFORE, under and by virtue of the powers in me vested, I do hereby proclaim, declare and make known as follows:—

1. In this Proclamation the expression "the Principal Proclamation" means the Police Proclamation, 1921 (Proclamation No. 56 of 1921), as amended by the Police (Amendment) Proclamation, 1922 (Proclamation No. 24 of 1922), the Police Proclamation Further Amendment Proclamation, 1924 (Proclamation No. 1 of 1924), and by the Police Proclamation Amendment Proclamation, 1927 (Proclamation No. 34 of 1927).

2. The Principal Proclamation is hereby amended by the deletion of the word "Commandant" wherever it appears therein, and by the substitution therefor of the word "Commissioner".

3. This Proclamation may be cited for all purposes as the Police Proclamation Amendment (Further Amendment) Proclamation, 1935, and shall be deemed to have come into operation and to have taken effect on the 1st day of April, 1935.

SOUTH WEST AFRICA CONSTITUTION COMMISSION.

It is hereby notified that the Commission which has been appointed —

- (1) to enquire into, and to report on, the effectiveness of the existing form of Government of the Mandated Territory of South West Africa, the reasons for the existing dissatisfaction therewith and the apparent failure thereof,
- (2) to consider, from a constitutional as well as state financial point of view, in what way the Government of the Territory could best be regulated so as to secure a more efficient administration and a greater measure of content amongst the inhabitants, due regard being had to the character of the Territory as Mandated Territory and the rules of international law governing the mandate and to the constitutional law of the Union, and to advise thereon,

will commence its deliberations in the near future.

In order that the work of the Commission may be facilitated and rendered more effective, interested persons and bodies desirous of giving evidence before the Commission are requested to submit such evidence in the form of written statements which should reach the Secretary to the Commission, c/o Prime Minister's Office, Pretoria, not later than the 10th July, 1935.
