**PROCLAMATIONS**

By HIS HONOUR DAVID GIDEON CONRADIE,  
ADMINISTRATOR OF SOUTH WEST AFRICA.

No. 12 of 1936.]

WHEREAS by paragraph *four* of the Agreement concluded between the Administrator of South West Africa and the Kapitein of the Rehoboth Community and the members of the Raad of the said community, which said Agreement was ratified and confirmed by Proclamation of the Administrator dated the twenty-eighth day of September, 1923 (Proclamation No. 28 of 1923), it was agreed *inter alia*, that the Administrator, after consultation with the Raad of the aforesaid community should possess the power to extend to the Territory referred to in the Agreement as the *Gebiet* the operation of any law in force in the Territory of South West Africa, if he considered such extension expedient or desirable in the interests of either the Territory of South West Africa or the *Gebiet*:

AND WHEREAS, by section *one* of the Rehoboth Affairs Proclamation, 1924 (Proclamation No. 31 of 1924), it was provided that, from and after the taking effect thereof, the Raad should cease to function within the *Gebiet*, and that all and several the powers, functions and duties vested by law in the Raad should vest in the Magistrate of the District of Rehoboth;

AND WHEREAS, after consultation with the Magistrate of the District of Rehoboth, the Administrator considers it expedient and desirable in the interests of the Territory of South West Africa and of the *Gebiet* to extend to the *Gebiet* the operation of the Motor Vehicle Ordinance, 1926 (Ordinance No. 9 of 1926), the Witchcraft Suppression Proclamation, 1933 (Proclamation No. 27 of 1933), the Extermination of Wild Dogs Ordinance, 1935 (Ordinance No. 6 of 1935), and the Meat Trade Control Ordinance, 1935 (Ordinance No. 8 of 1935);

NOW THEREFORE, under and by virtue of the powers in me vested, I do hereby proclaim, declare and make known as follows:—

The following laws, together with all amendments thereof or additions thereto which may hereafter be enacted, and all regulations which have been or may hereafter be made thereunder, shall be of full force and effect in the Territory referred to as the *Gebiet* in the Agreement contained in the Schedule to the Proclamation of the Administrator dated the twenty-eighth day of September, 1923 (Proclamation No. 28 of 1923), as amended by section *fourteen* of the Rehoboth Gebiet Affairs Proclamation, 1928 (Proclamation No. 9 of 1928):—

- (a) The Motor Vehicle Ordinance, 1926 (Ordinance No. 9 of 1926), as amended by the Licences, Wheel Tax and Motor Vehicle Licence Instalments Ordinance, 1932 (Ordinance No. 1 of 1932);
- (b) The Witchcraft Suppression Proclamation, 1933 (Proclamation No. 27 of 1933);
- (c) The Extermination of Wild Dogs Ordinance, 1935 (Ordinance No. 6 of 1935);
- (d) The Meat Trade Control Ordinance, 1935 (Ordinance No. 8 of 1935), as amended by the Meat Trade Control Amendment Ordinance, 1935 (Ordinance No. 20 of 1935).

EN NADEMAAL die Administrateur, na rugspraak met die Magistraat van die distrik Rehoboth, dit raadsaam en wenslik ag in die belange van die Gebied Suidwes-Afrika en van die *Gebiet* om die werking van die Motorvoertuig Ordonnansie 1926 (Ordonnansie No. 9 van 1926), die Onderdrukking van Towery Proklamasie 1933 (Proklamasie No. 27 van 1933) die Ordonnansie betreffende die Uitroeijing van Wildehonde 1935 (Ordonnansie No. 6 van 1935) en die Ordonnansie betreffende die Kontrole van Vleishandel 1935 (Ordonnansie No. 8 van 1935) tot die *Gebiet* uit te brei;
