VAN LUITENANT-KOLONEL SY EKSELLENSIE DIE HOOGEDELAGBARE DIE GRAAF VAN CLARENDON, LID VAN DIE MEES EERVOLLE GEHEIME RAAD VAN SY MAJESTEIT, GROOTKRUISRIDDER VAN DIE MEES ONDERSKEIE ORDE VAN SAINT MICHEL EN SAINT GEORGE, GOEWERNEUR-GENERAAL EN OPPERBEVELHEBBER IN EN OOR DIE UNIE VAN SUID-AFRIKA.

Kragtens en ingevolge die bevoegdheid my verleen by artikel twee van die „Fish Protection Act, 1893” (Wet No. 15 van 1893), van die Kaap de Goede Hoop, verklaar en proklameer ek hierby en maak ek hierby bekend dat die regulasies, wat hieronder verskyn, met ingang van die datum van publikasie van hierdie proklamasie die regulasies vervang wat gepubliseer is by Proklamasie No. 498 van 1909 (Kaap), soos gewysig deur Proklamasie No. 208 van 1930 en deur Proklamasie No. 228 van 1934.

1. Niemand mag op enigeen van die eilande, eilandjies en rotse in die Skedules hiervan uiteengesit, of op die strande daarvan, land nie behalwe kragtens 'n permit, uitgereik deur die Superintendent van die Staatsghwano-eilande, en onderworpe aan sodanige voorwaardes as wat daarin voorgeskryf mag word.

2. Niemand mag binne die territoriale waters van die Unie langs die kuslyn van die Provinsie Kaap de Goede Hoop of op of binne drie see-myle van die eilande, eilandjies of rotse soos in die Eerste Skedule hiervan uiteengesit, of op 'n ander plek binne genoemde Provinsie, behalwe op of bo 'n rivier of 'n meer, of die mond van 'n rivier, 'n pikkewyn (*Spheniscus demersa* Linn.), malgas (*Sula capensis* Licht.) of seeduiker (alle soorte) doodmaak, vang, skiet of agtervolg nie, behalwe kragtens 'n permit op aanbeveling van die magistraat van die distrik waarin bedoelde rivier, meer of riviermond geleë is, uitgereik deur 'n amptenaar wat deur die Minister van Landbou en Bosbou daartoe gemagtig is.

3. Niemand, behalwe 'n amptenaar wat behoorlik daartoe gemagtig is, mag binne die territoriale waters van die Unie langs die kuslyn van die Provinsie Kaap de Goede Hoop of op of binne 'n radius van drie see-myle van enigeen van die eilande, eilandjies en rotse soos in die Skedules hiervan uiteengesit, 'n rob doodmaak, vang of agtervolg nie: Met dien verstande dat dit gedurende die tydperk vanaf die 16de dag van April tot en met die 14de dag van Oktober in enige jaar wettig sal wees om robbe op of binne drie see-myle van enigeen van die eilande, eilandjies en rotse, soos in die Tweede Skedule hiervan uiteengesit, dood te maak, te vang of te agtervolg indien dit geskied kragtens 'n permit uitgereik deur die Superintendent van die Staatsghwano-eilande en op die voorwaardes in bedoelde permit uiteengesit.

**PROCLAMATION**

BY LIEUTENANT-COLONEL HIS EXCELLENCY THE RIGHT HONOURABLE THE EARL OF CLARENDON, A MEMBER OF HIS MAJESTY'S MOST HONOURABLE PRIVY COUNCIL, KNIGHT GRAND CROSS OF THE MOST DISTINGUISHED ORDER OF SAINT MICHAEL AND SAINT GEORGE, GOVERNOR-GENERAL AND COMMANDER-IN-CHIEF IN AND OVER THE UNION OF SOUTH AFRICA.

No. 158, 1936 (Union).]

Under and by virtue of the powers vested in me by section two of the Fish Protection Act, 1893 (Act No. 15 of 1893), of the Cape of Good Hope, I do hereby declare, proclaim and make known that the regulations appearing hereunder shall as from the date of publication of this Proclamation replace the regulations published under Proclamation No. 498 of 1909 (Cape), as amended by Proclamation No. 208 of 1930 and by Proclamation No. 228 of 1934:—

1. No person shall land upon any of the islands, islets and rocks specified in the Schedules hereto or upon the foreshore thereof, except under the authority of a permit issued by the Superintendent of the Government Guano Islands and upon such conditions as may be prescribed therein.

2. No person shall, except under the authority of a permit issued by the Superintendent of the Government Guano Islands and on such conditions as may be prescribed therein, kill, capture, shoot at or pursue any sea bird, or discharge fire-arms or explosives at any such bird, or use any other means whatsoever which may tend to disturb any such bird, or collect the eggs of any such bird, within the territorial waters of the Union along the coastline of the Province of the Cape of Good Hope or on or within three nautical miles of the islands, islets or rocks specified in the First Schedule hereto.

3. No person shall kill, capture, shoot at or pursue any penguin (*Spheniscus demersa* Linn.), malgas (*Sula capensis* Licht.) or sea duiker (any variety) within the territorial waters of the Union along the coastline of the Province of the Cape of Good Hope or on or within three nautical miles of any of the islands, islets and rocks specified in the Schedules hereto, or elsewhere within the said province, except on or above any river or any lake or the estuary of any river and under the authority of and in accordance with a permit issued, on the recommendation of the magistrate of the district within which such river, lake or estuary is situate, by an officer authorized thereto by the Minister of Agriculture and Forestry.

4. No person other than a duly authorized officer shall kill, capture or pursue any seal within the territorial waters of the Union along the coastline of the Province of the Cape of Good Hope or on or within a radius of three nautical miles of any of the islands, islets and rocks specified in the Schedules hereto: Provided that during the period from the 16th day of April to the 14th day of October in any year such killing, capture or pursuit shall be lawful if effected on or within three nautical miles of any of the islands, islets and rocks specified in the Second Schedule hereto, under the authority of a permit issued by the Superintendent of the Government Guano Islands and on conditions prescribed in such permit.

1. The *Official Gazette* will be published on the 1st and 15th day of each month; in the event of either of those days falling on a Sunday or Public Holiday, the *Gazette* will be published on the next succeeding working day.

2. Advertisements for insertion in the *Gazette* must be delivered at the office of the Secretary for South West Africa (Room 46, Government Buildings, Windhoek) in the languages in which they are to be published, not later than 4.30 p.m. on the *ninth* day before the date of publication of the *Gazette* in which they are to be inserted.

3. Advertisements will be inserted in the *Gazette* after the official matter or in a supplement to the *Gazette* at the discretion of the Secretary.

4. Advertisements will be published in the *Official Gazette* in the English, Dutch or German languages; the necessary translations must be furnished by the advertiser or his agent. It should be borne in mind however, that the German version of the *Gazette* is a translation only and not the authorised issue.

5. Only legal advertisements are accepted for publication in the *Official Gazette*, and are subject to the approval of the Secretary for South West Africa, who can refuse to accept or decline further publication of any advertisement.
