GROOTFONTEIN CATTLE IMPROVEMENT AREA:
APPOINTMENT TO BOARD.

The Deputy Administrator has been pleased, in terms of sub-section (4) of section three of the Cattle Improvement Ordinance, 1930 (No. 10 of 1930), as amended by the Cattle Improvement Ordinance Amendment Ordinance, 1935 (No. 10 of 1935), to appoint Mr. PAUL SCHNEIDER of the farm Okumutombe in the district of Grootfontein to be a member of the Cattle Improvement Board for the portion of the district of Grootfontein other than the Otavifontein Periodical Court area in place of Mr. Leonhard Ochs, deceased.

VILLAGE MANAGEMENT BOARD AREA OF
GROOTFONTEIN:
TRAFFIC SPEED LIMIT REGULATIONS.

It is hereby notified for general information that the Deputy Administrator has been pleased in terms of Section fourteen of the Village Management Boards Ordinance, 1937 (Ordinance No. 16 of 1937), to make the following Regulations to be of force and effect within the Village Management Board Area of Grootfontein as from the first day of February, 1938:—

1. The speed at which animals, vehicles or motors may be ridden or driven in any of the streets within the Village Management Board Area shall not in the case of animals and vehicles exceed eight miles an hour, and in the case of motors twenty miles an hour.

2. Notwithstanding anything contained in these Regulations every driver of a vehicle or motor when turning a street corner shall slow down and shall drive at a speed which will not endanger the safety of any person, animal or thing whatsoever.

3. Niemand sal kragtens hierdie Regulasies veroordeel word nadat hy enige snelheidsgrens oortref het, slegs volgens die mening van een getuie aangaande die snelheid.

4. Niks in hierdie Regulasies bevat, beïnvloed die bepalinge van die Dorpsbestuursraadsgebied Grootfontein, Regulasies op Strate en Verkeer, soos gepubliseer in Goewermentskennisgewing No. 169 van 16 Oktober 1933.

5. Elke persoon, wat hom skuldig maak aan 'n oortreding van enige van hierdie Regulasies, sal by skuldigbevinding onderhewig wees aan 'n boete van hoogstens twintig pond of, by wanbetaling, aan gevangenisstraf met of sonder harde arbeid vir 'n tydperk van hoogstens drie maande.

3. No person shall be convicted under these Regulations for exceeding any limit of speed merely on the opinion of one witness as to the rate of speed.

4. Nothing in these Regulations contained shall affect the provisions of the Village Management Board of Grootfontein Street and Traffic Regulations published in Government Notice No. 169 of the 16th October, 1933.

5. Every person contravening any of these Regulations shall upon conviction be liable to pay a fine not exceeding twenty pounds or in default of payment, to undergo imprisonment with or without hard labour for a period not exceeding three months.

VERPLIGTENDE GELYKTYDIGE DIP VAN KLEINVEE IN SUIDWES-AFRIKA.

Ingevolge en kragtens die bevoegdhede hom verleen deur artikel *sestien* van "De Veeziekten Proklamasie 1920" (Proklamasie No. 28 van 1920), het die Waarnemende Administrateur as volg gelas:—

1. Elke eienaar van skape of bokke in al die distrikte van Suidwes-Afrika, behalwe in daardie gedeeltes van die Omaruru, Outjo, Grootfontein en Gobabis distrikte wat buitekant die Polisieonegrens geleë is en die distrik Ovamboland, moet sodanige vee tweekeer in 'n goedgekeurde dip laat dip en moet hulle in die dip vir minstens twee minute indruk. Die tweede dip moet in elke geval binne minstens agt en nie meer as tien dae na die datum van die eerste dip plaasvind nie.

2. Die voormelde dip moet gedurende die maand van April 1938 plaasvind.

COMPULSORY SIMULTANEOUS DIPPING OF SMALL STOCK IN SOUTH WEST AFRICA.

Under and by virtue of the powers in him vested by section *sixteen* of the Diseases of Stock Proclamation, 1920 (Proclamation No. 28 of 1920), the Deputy Administrator has ordered as follows:—

1. Every owner of sheep or goats in all the districts of South West Africa, except in those portions of the Omaruru, Outjo, Grootfontein and Gobabis districts which are situated outside the Police Zone boundary and the district of Ovamboland, shall cause such stock to be dipped twice in an approved dip, keeping them immersed in the dip for not less than two minutes. The second dipping shall, in every case take place within not less than eight and not more than ten days after the date of the first dipping.

2. The aforesaid dipping shall be carried out during the month of April, 1938.

Die bostaande stel, te Walvisbaai Draadloosstasie, word vervang deur 'n stel met groter kragvermoë.

One 30 horsepower, 700 R.P.M 3 cylinder vertical, crude oil Schleuter-Diesel engine, Airless Injection type complete with fuel tank, piping and exhaust, together with minor spares and accessories, but not including cooling tanks. This engine is direct coupled to a generator, also for sale, comprising:—

One Direct Current Shunt wound generator, 220/270 volt 55 ampères 700 R.P.M. Witton type complete with field regulator.
