WYSIGING VAN DIE REÛLS BETREFFENDE DIE VOORWAARDES WAARONDER GEREGISTREERDE VROEDVROU HUL BEROEP KAN UITOEFEN.

In die uitoefening van die bevoegdheid hom verleen by subartikel (4) van artikel vier-en-negentig van die Wet op Geneeshere, Tandartse en Aptekers, No. 13 van 1928, heg die Minister van Volksgesondheid sy goedkeuring aan die volgende wysigings van die reëls betreffende die voorwaardes waaronder geregistreerde vroedvroue hul beroep kan uitoefen, gemaak deur die Suid-Afrikaanse Geneeskundige Raad ingevolge artikel vier-en-negentig van bogemelde Wet en gepubliseer by Goewermentskennisgewing No. 630 van 17 April 1931, soos gewysig by Goewermentskennisgewings Nos. 1563 van 1932 en 1104 van 1937:—

Reël 4:

Voeg nuwe paragraaf in—  
“(e) Gesteriliseerde watte.”

Reël 17:

Voeg die volgende by:—

“Onmiddellik na die geboorte van die kindjie moet die vroedvrou die ogies sorgvuldig met boorsuur of 'n ander geskikte oplossing of met vooraf gekookte en afgekoelde skoon water was en in hierdie verband 'n skoon glas of koppie en gesteriliseerde watte gebruik. Daarna moet sy of 'n druppel silwernitrat van 1 persent, of 'n druppel oplossing van protargol van 5 persent in elke ogie gooi.”

Reël 24:

Voeg die volgende in aan die einde van die eerste sin:—  
“'n Vroedvrou moet besonderhede van elke inwendige ondersoek wat deur haar gedoen is, in haar register aanteken.”

AMENDMENT TO THE RULES REGARDING THE CONDITIONS UNDER WHICH REGISTERED MIDWIVES MAY CARRY ON THEIR CALLING.

The Minister of Public Health in the exercise of the powers conferred on him by sub-section (4) of section ninety-four of the Medical, Dental and Pharmacy Act, No. 13 of 1928, approves of the following amendments to the rules made by the South African Medical Council under section ninety-four of the said Act regarding the conditions under which registered midwives may carry on their calling published under Government Notice No. 630 of 17th April, 1931, as amended by Government Notices Nos. 1563 of 1932, and 1104 of 1937:—

Rule 4:

Insert new paragraph—  
“(e) Sterile cotton wool.”

Rule 17:

Add the following:—

“Immediately after the birth of the child the midwife shall carefully cleanse its eyes with boracic or of er suitable solution, or with clean and previously boiled and cooled water, using a clean glass or cup and sterile cotton wool, and instil into each eye a drop of either 1 per cent. silver nitrate or 5 per cent. protargol solution.”

Rule 24:

At the end of the first sentence, insert the following:—  
“A midwife shall enter in her register particulars of every internal examination made by her.”

SOUTH AFRICAN MEDICAL COUNCIL.—RULES FOR THE TRAINING AND EXAMINATION OF MIDWIVES

The Minister of Public Health in exercise of the powers conferred on him by sub-section (4) of section ninety-four of the Medical, Dental and Pharmacy Act, No. 13 of 1928, approves of the following amendment to the rules for the training and examination of midwives made by the South African Medical Council under sub-section (2) (j) of the said section of the Act, published under Government Notice No. 968 of the 12th June, 1931, as amended by Government Notices Nos. 1773 of 1931, 627 of 1933, 516 of 1936, 52 of 1936, 117 of 1937 and 79 and 1181 of 1939:—

Reël 4 (2) (c):

Skrap die punt aan die end van die paragraaf en vervang dit deur 'n komma, en voeg onderstaande woorde by:—

“of in die geval van opleidingskole vir natuurle-vroedvroue in plattelandse streke onder toestande soort-gelyk aan dié wat in 'n natuurlekraal heers.”

Reël 4 (4):

Voeg 'n nuwe subklousule in, as volg:—

“(4) *Verlof.*

Aan leerlingvroue word vakansieverlof van 14 dae toegestaan; met dien verstande dat aan kandidate wat opleiding vir 'n tydperk van 18 maande ondergaan, geen vakansieverlof gedurende die eerste 6 maande van hul opleiding, toegestaan word nie.”

Reël 5 (1):

Skrap die woorde “nege maande” en vervang dit deur die woorde “ses maande.”

Skrap paragraaf (a), na die woorde “die eksamens moet onderstaande onderwerpe omvat”, en voeg in:—

“(A) *Vir die eerste eksamen—*

- (a) die anatomie en fisiologie van die vroulike bekken en sy organe, en van die borste;
- (b) algemene inleidende anatomie en fisiologie; die beginsels van higiëne en assainering wat betref die huis, die diët en die persoon; die vroedvrou se aandeel in die verspreiding van 'n beter kennis van higiëne onder die vroue wat sy behandel;
- (c) teorie en praktyk van kraamverpleging; etiese aspekte; hospitaal-etiket; afdelingswerk; versorging van pasiënte; versorging van linne en beddegoed; kombersbaddens; was van mond, hare en tande; opmaak van beddens; versorging van die rug; inkaart-bringing; voorbereiding vir ondersoeke van die endelderm en die skede; afspors; baddens en inwikkelings; uitwerpsels; ondersoeke van die urine en ontlasing; die hou van monsters; urine-aflating, kateterisasie; sorg van kateters, uitspoeling van die blaas; verslag doen en ontvang; voeding van die pasiënte — spesiale diëte; toediening van medisyne; lykversorging.

(B) *Vir die finale eksamen—*

(a) die onderwerpe vir die eerste eksamen, en ook—

Reël 5 (2):

Skrap die bestaande reël en vervang dit deur die volgende:—

“'n Kandidaat word nie toegelaat om haar vir die eerste eksamen te laat inskryf nie voordat sy haar opleiding vir die eerste eksamen soos in hierdie reëls vasgestel, voltooi het. Die kandidaat moet die volgende voorlê:—

'n Sertifikaat onderteken deur die matrone van die opleidingskool ten effekte dat sy praktyk van die inrigting gereeld vir 'n tydperk van ses maande bygewoon en 'n reeks lesings en demonstrasies vir die eerste eksamen ooreenkomstig die reëls bygewoon het. 'n Kandidaat word nie tot die finale eksamen toegelaat nie voordat sy haar opleiding voltooi het. Sy moet die volgende voorlê:—

- (a) 'n Sertifikaat, onderteken deur die matrone van die opleidingskool, ten effekte dat sy die praktyk van die inrigting gereeld vir die deur die reëls vasgestelde tydperk, bygewoon het en dat sy die lesings en demonstrasies soos daarin bepaal, bygewoon het.
- (b) 'n Sertifikaat, onderteken deur die matrone van die opleidingskool, ten effekte dat sy die getal gevallende versorg en die getal kraamvroue verpleeg het soos in hierdie reëls vasgestel.
- (c) 'n Sertifikaat, onderteken deur 'n geregistreerde geneesheer, ten effekte dat haar gesondheid sulks is dat haar pasiënte geen gevaar sal loop om as gevolg van haar toelating tot die vroedvroupraktyk besmet te word nie.
- (d) 'n Sertifikaat van goeie gedrag deur 'n geregistreerde geneesheer, predikant, magistraat of vrede-regter.
- (e) Bewys dat sy in die eerste eksamen geslaag het.”

Rule 4 (2) (c):

Delete the full stop at the end of the paragraph and substitute a comma, and add the following words:—

“or in the case of training schools for native midwives in rural areas under conditions similar to those pertaining in a native kraal.”

Rule 4 (4):

Insert a new sub-clause as follows:—

“(4) *Leave.*

Pupil midwives shall be allowed 14 days vacation leave; provided that candidates undergoing a period of 18 months training shall not be granted vacation leave during the first 6 months of their training.”

Rule 5 (1):

Delete the words “nine months” and substitute the words “six months”.

After the words “the examinations shall include within their scope the following”, delete paragraph (a), and insert:—

“(A) *For the first examination.*

- (a) The anatomy and physiology of the female pelvis and its organs, and of the breasts;
- (b) general introductory anatomy and physiology; the principles of hygiene and sanitation as regards home, diet and person; the midwife's part in spreading a better knowledge of hygiene among the women she attends;
- (c) theory and practice of midwifery nursing; ethical aspects; hospital etiquette; ward work; care of patients; care of linen and bedding; blanket bathing; cleansing of mouth, hair and teeth; bed-making; care of back; charting; preparation for rectal and vaginal examinations; sponging; baths and packs; excretar; examinations of urine and stools; keeping of specimens; micturition, catheterization; care of catheters, bladder lavage; giving and receiving of reports; feeding of patients—special diets; administration of medicines; care of the dead.”

(B) *For the final examination.*

(a) The subjects for the first examination, and also:—

Rule 5 (2):

Delete the existing rule and substitute the following:—

“A candidate shall not be allowed to enter for the first examination until she shall have completed her training for the first examination as laid down in these rules. She shall submit—

a certificate signed by the matron of the training school that she has regularly attended the practice of such institution for a period of six months and has attended a course of lectures and demonstrations “or the first examination in terms of the rules.”

A candidate shall not be admitted to the final examination until she has completed her training. She shall be required to submit the following:—

- (a) A certificate signed by the matron of the training school that she has regularly attended the practice of such institution for the period laid down by these rules, and attended lectures and demonstrations as laid down therein;
- (b) a certificate signed by the matron of the training school that she has attended the number of cases and nursed the number of lying-in women as laid down by these rules;
- (c) a certificate signed by a registered medical practitioner to the effect that her health is such that no danger to her patients would be involved by her admission to practise as a midwife;
- (d) a certificate from a registered medical practitioner, minister of religion, magistrate or justice of the peace as to good character;
- (e) evidence of having passed the first examination.”

## Reël 5 (3):

Skrap die bestaande reël en vervang dit deur die volgende:—

“Minstens vyf vrae word vir die skriftelike gedeeltes van die preliminêre en finale eksamens gestel, en die kandidate word drie uur toegelaat om dit te beantwoord.”

## Reël 5 (4):

Skrap die woord “eksamen” waar dit vir die eerste keer voorkom, en vervang dit deur die woord “eksamens”.

## Reël 5 (8):

Skrap die bestaande reël en vervang dit deur die volgende:—

“Onderstaande gelde is deur kandidate vir die eksamen aan die Raad betaalbaar:—

(a) 'n bedrag van £1. 1s. wanneer aansoek om toelating tot die eerste eksamen gedoen word. Indien kandidate druij, kan hulle hul vir hereksamen aanmeld teen betaling van dieselfde bedrag by elke geleentheid;

(b) 'n Bedrag van £3. 3s. wanneer aansoek om toelating tot die finale eksamen gedoen word. Dit sluit registrasie as 'n vroedvrou in indien en wanneer die kandidaat in die eksamen slaag. Indien 'n kandidaat druij, kan sy, onderworpe aan reël 4 (7), weer tot die eksamen toegelaat word teen betaling van 'n bedrag van £2. 2s.”

## Rule 5 (3):

Delete the existing rule and substitute the following:—

“In the written portions of the preliminary and final examinations, not less than five questions shall be set and the candidates shall be allowed three hours to answer them.”

## Rule 5 (4):

Delete the word “examination” where it occurs for the first time, and substitute the word “examinations”.

## Rule 5 (8):

Delete the existing rule and substitute the following:—

“The following fees shall be payable to the Council by candidates for examination:—

(a) On application for admission to the first examination the fee of £1. 1s. In the case of failure to pass, candidates may present themselves for re-examination on payment of a similar fee for each occasion;

(b) on application for admission to the final examination, a fee of £3. 3s., which will include registration as a midwife if and when the candidate passes the examination. In the case of failure to pass, a candidate may, subject to Rule 4 (7), be re-admitted to examination on payment of a fee of £2. 2s.”
