### AI-AIS HOT SPRINGS.

The Administrator has been pleased under and by virtue of the powers in him vested by section one of the Crown Lands (Trespass) Proclamation, 1919 (Proclamation No. 7 of 1919), as amended by the Crown Lands (Trespass) Amendment Proclamation, 1937 (Proclamation No. 4 of 1937), and the Crown Lands (Trespass) Amendment Proclamation, 1938 (Proclamation No. 31 of 1938), to approve of the deletion of regulation 5 appearing in the regulations published under Government Notice No. 24 of the 10th February, 1937, and the substitution therefor of the following regulation:—

5. A fee of 6/- per month, or 2/- per week or portion thereof for adults, and one half of the above amounts for children under the age of 16 years, shall be payable in advance to the Superintendent for the privilege of residing in the area, provided that no fee shall be payable in respect of the first twenty-four hours of residence.

The said moneys shall be paid into the Territory Revenue Fund.

### AI-AIS-WARMBRONNE.

Dit het die Administrateur behaag om, op grond van en kragtens die bevoegdhede hom verleen deur artikel een van die "Kroonlanden (Overtreding) Proklamaties, 1919" (Proklamasie No. 7 van 1919), soos gewysig deur die Kroongrond-(Overtreding) Wysigingsproklamasie, 1937 (Proklamasie No. 4 van 1937), en die Kroongrond-(Overtreding) Wysigingsproklamasie 1938 (Proklamasie No. 31 van 1938), sy goedkeuring te heg aan die skrapping van regulasie 5 wat in die regulasies verskyn wat onder Goewermentskennisgewing No. 24 van 10 Februarie 1937 gepubliseer is en die vervanging daarvan deur die volgende regulasie:—

#### PROHIBITION OF REMOVAL OF VEGETABLE PRODUCTS FROM NORTHERN NATIVE TERRITORIES.

The Administrator has been pleased, under and by virtue of the powers in him vested by sections *sixteen* and *twenty-three* of the Disease of Stock Proclamation, 1920 (Proclamation No. 28 of 1920), to make the following regulations:—

1. No person shall remove, or cause or permit to be removed any vegetable products out of the Closed Area for Stock as defined by Government Notice No. 37, dated the 13th March, 1935, and Government Notice No. 143, dated the 1st October, 1935, unless such removal is authorised by permit.
2. A permit for such removal may be obtained from the Native Commissioner, Ovamboland, Assistant Native Commissioner, Okavango Native Territory, the Officer-in-Charge of Native Affairs in the Kaokoveld or a Police Officer stationed on the border of the aforesaid Closed Area, i.e., on the Police Zone Boundary, provided its issue has been sanctioned by the Senior Veterinary Surgeon.

No company is excepted from this obligation unless it has been granted and holds a special certificate of exemption from the operation of the Proclamation as provided in section *eleven* (2) of the Proclamation.

2. The annual return in question is the means provided by law for ascertaining that the duty imposed on shares and debentures of South West African Companies belonging to the estates of deceased persons has in every case been paid to the revenue of this Territory. The making of the return by every company is consequently indispensable, and it is desired to notify that compliance will be required without fail.

3. The law imposes a daily penalty on directors, managers, or other responsible representatives of companies for failure to make the return, and also renders companies liable to make good to the revenue any duty (with 12 per cent interest added) lost or unpaid through any default of the company.

4. Companies are therefore invited to make the return at an early date, but in any case not later than the 31st July, and to note that the return must be rendered to the SECRETARY FOR SOUTH WEST AFRICA, and not the Registrar of Companies.

5. If no persons have ceased to be shareholders as specified above, a "Nil" return must be rendered.

### KENNISGEWING AAN MAATSKAPPYE—"DE BOEDEL-BELASTING PROKLAMATIE, 1920".

Die volgende kennisgewing word vir algemene informasie gepubliseer.

1. Van al die maatskappye geregistreer, ingelyf of handel-drywende in Suidwes-Afrika word kragtens artikel *dertien* van bogenoemde Proklamasie verlang 'n opgawe te doen, voor 31 Julie, van die name en adresse van al die persone wat weens dood opgehou het om aandeelhouers te wees vanaf 30 Junie 1939. 2. From the point where District Road No. 12 crosses District Road No. 14 on the farm Kumakams No. 68 generally northwards via the farms Kumakams No. 68, Blenheim No. 69 and Huams No. 67 to the place called Aufsteig on the last mentioned farm.

From a point on the farm Maguams No. 70 generally southwards via the farms Maguams No. 70, Blenheim No. 69 and Huams No. 67 to the place called Aufsteig on the last mentioned farm.
