Op enige openbare weg in 'n stad, dorp of dorpie moet alle persone wat die verkeer op sodanige weg reël of alle ander gebruikers daarvan die voorkeur van deurgang aan voertuie wat die eiendom van die Regering van die Unie by sy Departement van Verdediging is, gee wanneer die nadering van hierdie voertuie deur middel van skel, uitgerekte fluite met 'n sirene aangedui word.

As die nadering van enige sodanige voertuig op hierdie wyse aangedui word, moet die drywers van alle ander voertuie dit onmiddellik vry baan gee deur of heeltemaal na die linkerkant van die weg pad te gee, of stil te hou, of iets anders te doen wat die beste daarop bereken is om sodanige voertuig ongehinderd deur te laat.

3. Iemand wat 'n bepaling in hierdie orders vervat en wat hy pligshalwe moet nakom, nie nakom nie of nalaat om dit na te kom, is skuldig aan 'n oortreding van regulasie 37 (3) van gemelde Landsnoodtoestand-regulasies en kan by skuldigbevinding tot 'n boete van hoogstens £200 of tot gevangenisstraf van hoogstens 'n jaar of tot sodanige boete sowel as sodanige gevangenisstraf veroordeel word.

It is hereby notified for general information that, under and by virtue of the powers vested in me by Regulation 37 (2) of the National Emergency Regulations, promulgated under Proclamation No. 35 of 1940, and validated by section two of the War Measures Act, 1940 (Act No. 13 of 1940), I, JAN CHRISTIAAN SMUTS, in my capacity as Minister of Defence, do hereby make the following Orders, to be in force throughout the Union:—

1. All motor vehicles owned by the Government of the Union in its Department of Defence are hereby exempted:—

- (a) from the operation of any law imposing any limit of speed upon motor vehicles driven on public roads;
- (b) from the operation of any by-law or regulation relating to the regulation or control of vehicular traffic on public roads, made by any municipality or other local authority; Provided that the exemption conferred by this paragraph shall only be enjoyed by a motor vehicle so owned while it is being used on a special mission sanctioned by the Chief of the General Staff and if its approach is signified by means of a siren emitting prolonged and high-pitched blasts.

2. On any public road in a city, town or village, priority of way shall be given by all persons regulating traffic thereon and by all other users thereof to vehicles so owned when the approach of the latter is signified by means of a siren emitting prolonged and high-pitched blasts. If the approach of any such vehicle is so signified, the drivers of all other vehicles shall immediately yield to it the right of way, either by drawing in to the extreme left-hand side of the road or by stopping or by adopting such other course as is best calculated to permit of the unobstructed passage of such vehicle.

3. Any person who fails or neglects to comply with any provision of these Orders with which it was his duty to comply, is guilty of an offence under Regulation 37 (3) of the said National Emergency Regulations, and liable, on conviction, to a fine not exceeding £200 or to imprisonment for a period not exceeding one year or to both such fine and such imprisonment.
