**UITHOU VAN DIE OOSTELIKE CAPRIVI ZIPFEL AS  
'N NATURELLERESERWE.**

Hierby word vir algemene informasie bekendgemaak dat die Minister van Naturellesake, ingevolge die bevoegdheid hom verleen by artikel *sestien* van die Proklamasie insake Naturelle-administrasie, 1922 (No. 11 van 1922), uitgevaardig deur die Administrateur van Suidwes-Afrika, gelees met artikel *drie* van die Proklamasie op die Administrasie van die Oostelike Caprivi Zipfel, 1939 (No. 147 van 1939), uitgevaardig deur die Goewerneur-generaal van die Unie van Suid-Afrika, dit raadsaam geag het om die Oostelike Caprivi Zipfel, met uitsluiting van enige gebied wat wetlik gehuur of andersins wetlik toegeken is aan ander persone as naturelle vir so lank as genoemde gebiede aldus verhuur of andersins wetlik toegeken bly, as 'n naturellerereserwe uit te hou.

**SETTING ASIDE OF THE EASTERN CAPRIVI ZIPFEL  
AS A NATIVE RESERVE.**

It is hereby notified for general information that the Minister of Native Affairs has deemed it desirable, under the powers vested in him by section *sixteen* of the Native Administration Proclamation, 1922 (No. 11 of 1922), issued by the Administrator of South West Africa, read with section *three* of the Eastern Caprivi Zipfel Proclamation, 1939 (No. 147 of 1939), issued by the Governor-General of the Union of South Africa, to set aside as a Native Reserve the Eastern Caprivi Zipfel, exclusive of any area lawfully leased or otherwise lawfully granted to persons other than Natives for so long as the said areas shall remain so leased or otherwise lawfully granted.
