### NATIONAL EMERGENCY REGULATIONS.

It is hereby notified for general information that a person in Germany as defined in Regulation 1 of the National Emergency Regulations now includes persons in Bulgaria, Hungary, Roumania, Yugoslavia, Greece and the Greek Islands with the exception of Crete in view of the occupation of those countries by Germany and the provisions of Regulation 8 of the National Emergency Regulations and of Government Notice No. 845 of 1940, consequently apply to those countries.

Persons in the Union who owe money to, or hold money, goods or securities for persons in the countries mentioned are required to notify the Custodian of Enemy Property, the Treasury, Pretoria, accordingly.

Persons in the Union who have claims against persons in the countries mentioned may register them with the Custodian of Enemy Property.

The provisions of the regulation and Government Notice quoted herein now apply to Germany, including Austria and Czechoslovakia, Italy, the German occupied portions of Poland and of France, Belgium, the Channel Islands, Denmark, Holland, Luxembourg, Norway, Bulgaria, Roumania, Hungary, Yugoslavia, Greece and the Greek Islands with the exception of Crete.

### CIRCUIT COURTS.

Under and by virtue of the powers conferred by sections two and three of the Further Administration of Justice Proclamation, 1920, the Administrator has directed that there shall be a Central and Southern Circuit district comprising the Magisterial districts of Aroab, Bethanie, Gibeon, Gobabis, Karibib, Keetmanshoop, Luderitz, Maltahohe, Okahandja, Rehoboth, Swakopmund, Warmbad and Windhoek and that a Circuit Court for the said Circuit district shall be held at Windhoek on Monday the Ninth day of June, 1941, at 10 o'clock in the forenoon, provided that in the event of the Judge being prevented by some unforeseen cause of delay from opening the Circuit Court at the place and on the day fixed for the purpose, such Circuit Court shall be opened on a day as soon thereafter as conveniently may be.

Hierby word vir algemene informasie bekendgemaak dat 'n persoon in Duitsland, soos in paragraaf 1 van die Landsnoodtoestandregulasies omskrywe, nou persone in Boelgarye, Hongarye, Roemenië, Suid-Slawië, Griekeland en die Griekse eilande met uitsondering van Kreta, insluit, met die oog op die besetting van hierdie lande deur Duitsland, en die bepalings van regulasie 8 van die Landsnoodtoestandregulasies en van Goewermentskennisgewing No. 845 van 1940 is derhalwe op hierdie lande van toepassing.

Personne in die Unie wat geld skuld aan of geld, goedere of sekuriteite hou ten behoeve van persone in bovenoemde lande, moet die Bewaarder van Vyandseiendom, Tesourie, Pretoria, dienooreenkomsdig in kennis stel.

Personne in die Unie wat eise het teen persone in bovenoemde lande kan hul eise by die Bewaarder van Vyandseiendom regstreer.

Die bepalings van die regulasie en die Goewermentskennisgewing hierin vermeld is nou van toepassing op Duitsland, met inbegrip van Oostenryk en Tseego-Slowakye, Italië, die Duitsbesette gedeeltes van Poland en Frankryk, België, die Kanaal-eilande, Denemarke, Holland, Luksembourg, Noorweë, Boelgarye, Roemenië, Hongarye, Suid-Slawië, Griekeland en die Griekse eilande met uitsondering van Kreta.

## CATTLE IMPROVEMENT REGULATIONS.

The Administrator has been pleased under and by virtue of the powers in him vested by section *thirteen* of the Cattle Improvement Consolidation Ordinance, 1941 (Ordinance No. 14 of 1941), to make the following regulations:—

## REGULATIONS.

## 1. In these regulations —

“the Ordinance” means the Cattle Improvement Consolidation Ordinance, 1941 (Ordinance No. 14 of 1941), and any amendments thereof;

“board” means a board appointed by the Administrator in terms of section *three* of the Ordinance;

“cattle improvement area” means any district or defined area duly declared to be a cattle improvement area by proclamation issued under section *one* of the Ordinance;

“registered bull” means a bull the pedigree of which has been registered with a Society approved by the Administrator;

All other expressions shall, unless inconsistent with the context, bear the meanings assigned to them in the Ordinance.

2. Members of a Board constituted under section *three* of the Ordinance other than public servants shall be entitled to the following allowances for the time necessarily spent in attendance at Board meetings and in travelling to and returning from the place of such meetings or otherwise in connection with their duties as such members:—

- (a) Subsistence allowance at the rate of £1 per day or portion thereof.
- (b) Free transport by rail.
- (c) Horse transport allowance at the rate of 2d. per mile.
- (d) Motor transport allowance at the rate of 9d. per mile, plus an additional 1d. per mile in respect of each passenger carried, whose attendance is necessary in connection with the activities of the Board.

3. Any person who desires to introduce an unapproved bull into a cattle improvement area, in terms of section *six* (b) (i) of the Ordinance shall make application to the officer appointed for the area in the manner prescribed hereunder at least one week before the date on which he wishes to introduce such bull.

## BEESTEVERBETERINGSREGULASIES.

Ingevolge en kragtens die bevoegdhede hom verleen deur artikel *dertien* van die Beesteverbeterings-Konsolidasieordonnansie 1941 (Ordonnansie No. 14 van 1941) het dit die Administrateur behaag, om die volgende regulasies te maak:—

## REGULASIES.

## 1. In hierdie regulasies beteken —

“die Ordonnansie” — die Beesteverbeterings-Konsolidasieordonnansie 1941 (Ordonnansie No. 14 van 1941) en enige wysigings daarvan;

“raad” — ‘n raad aangestel deur die Administrateur ingevolge artikel *drie* van die Ordonnansie;

“beesteverbeteringsgebied” — enige distrik of omskreve gebied behoorlik tot ‘n beesteverbeteringsgebied verklaar deur proklamasie uitgevaardig kragtens artikel *een* van die Ordonnansie;

“geregistreerde bul” — ‘n bul waarvan die stamboom geregistreer is by ‘n vereniging goedgekeur deur die Administrateur.

Aan alle ander uitdrukings, tensy onbestaanbaar met die samehang, sal die betekenis geheg word, wat aan hulle toegewys is in die Ordonnansie.

2. Lede van die Raad, saamgestel kragtens artikel *drie* van die Ordonnansie wat nie staatsamptenare is nie, is geregtig op die volgende toelae vir die tyd noodsaaklik bestee aan die bywoning van raadsvergaderings en die reis na en van die plek van sodanige vergaderings, of andersins in verband met hulle pligte as sodanige lede:—

(a) Onderhoudstoelaag teen £1 per dag of gedeelte daarvan.

(b) Vrye vervoer per spoor.

(c) Toelaag vir vervoer met perde teen 2d. per myl.

(d) Toelaag vir motorvoervoer teen 9d. per myl, plus ‘n addisionele 1d. per myl vir elke passasier wat saamry, wie se aanwesigheid nodig is in verband met die aktiwiteite van die Raad.

3. Enige persoon wat wens om ‘n nie-goedgekeurde bul in ‘n beesteverbeteringsgebied in te voer ooreenkomsdig artikel *six* (b) (i) van die Ordonnansie, moet aansoek doen by die beampete aangestel vir die gebied op ‘n wyse soos hieronder voorgeskrywe, tenminste ‘n week voor die datum waarop hy sodanige bul wens in te voer.



4. Every non-registered bull which has been duly inspected and approved by a Board shall in terms of subsection (1) of section *seven* of the Ordinance forthwith be marked in the left ear with a tattoo mark (thus: )



and the owner of such bull shall also forthwith cause it to be branded on the left forearm with two arched A's, with

the one inverted and the arches facing (thus: )

5. Every non-registered bull which has been duly inspected and provisionally approved by a Board shall, in terms of sub-section (2) of section *seven* of the Ordinance forthwith be marked in the left ear with a tattoo mark (thus: ) and the owner of such bull shall also



forthwith cause it to be branded on the left forearm with one arched A (thus: ).

6. When a bull has been duly inspected, and approved or provisionally approved, and branded and marked as described in regulation 4 or 5 as the case may be, the officer shall allot to such bull a distinctive mark consisting of the dominant letter for the district as set forth in the second schedule to the Stock Brands Ordinance, 1931 (Ordinance No. 8 of 1931) and a number which shall be the serial number of that bull in the register to be kept in terms of sub-section (4) of section *seven* of the Ordinance.

Such distinctive mark shall forthwith be tattooed in the right ear of the animal to which it has been allotted.

7. The owner of any registered bull shall cause such animal to be branded on the left forearm with an inverted arched A (thus: ) and shall furnish the officer appointed for the cattle improvement area wherein such animal is kept with full particulars regarding its breed, age and description, and proof of registration, giving Studbook or Herd-book number and identification brand or mark.

The officer aforesaid shall record all these particulars in a register to be kept by him.

8. When an unapproved bull has been duly inspected and disapproved by a Board the owner of such bull shall in terms of sub-section (3) of section *seven* of the Ordinance, forthwith cause it to be branded on the left forearm with an arched A branded horizontally with the arch pointing to the right (thus: ), unless the owner is agreeable to the immediate castration of said bull under the supervision of the Board or immediately notifies his intention to appeal.

9. Where a bull which has been previously inspected and provisionally approved by a Board in terms of section *four* of the Ordinance, is subsequently disapproved, the owner of such animal shall then return to the officer concerned the certificate of inspection and provisional approval previously issued for purposes of cancellation and the cancellation thereof shall be denoted on the animal itself by means of an arched A branded horizontally with the arch pointing to the right (thus: ) immediately above the arched A branded on the animal's left forearm at the time of the original inspection and provisional approval, unless the owner is agreeable to the immediate castration of the bull under the supervision of the Board or immediately notifies his intention to appeal.

10. When a bull has been inspected and approved or provisionally approved by a Board and marked in accordance with these regulations, the officer concerned shall issue to the owner of the bull a certificate in the following form:—





5. Elke ongeregistreerde bul wat behoorlik onderzoek en voorlopig goedgekeur is deur 'n Raad, ooreenkomsdig subartikel (2) van artikel *sewe* van die Ordonnansie, moet onmiddellik aan die linkeroor met 'n tatooëermerk gemerk word (aldus: ) en die eienaar van sodanige bul moet dit



onmiddellik op die linker voorbeen met 'n gewelfde A (aldus: ) laat brandmerk.

6. Waar 'n bul, wat voorheen onderzoek en voorlopig goedgekeur is deur 'n Raad, later afgekeur word, moet die eienaar van sodanige bul die sertifikaat van inspeksie en voorlopige goedkeuring voorheen uitgereik, aan die betrokke beampete terugbesorg om dit te kanselleer en die kansellering daarvan moet op die dier self aangedui word deur middel van 'n gewelfde A, wat horisontaal met die boog na regs (aldus: ), net bokant die gewelfde A op die dier se linker voorbeen gebrand ten tyde van die oorspronklike inspeksie en voorlopige goedkeuring, gebrand word, tensy die eienaar bereid is om die bul onmiddellik te laat kastreer onder toesig van die Raad of dadelik kennisgegee van sy voorneme om te appelleer.

10. As 'n bul ondersoek en goedgekeur of voorlopig goedgekeur is deur 'n Raad en gemerk is in ooreenstemming met hierdie regulasies, moet die betrokke beampete 'n sertifikaat in die volgende vorm aan die eienaar van die bul uitreik:—
