**PROKLAMASIE  
VAN SY EDELE DAVID GIDEON CONRADIE,  
ADMINISTRATEUR VAN SUIDWES-AFRIKA.**

No. 15 van 1941.]

NADEMAAL dit wenslik is om die wet wat voorsiening maak vir die regering van Ovamboland verder te wysig,

SO IS DIT dat ek, op grond van en kragtens die bevoegdhede my verleen, hiermee proklameer, verklaar en as volg bekend maak:

1. Artikel *drie* van die Ovambolandse Aangeleenthede Proklamasie 1929 (Proklamasie No. 27 van 1929) word hiermee as volg gewysig:

(i) deur die woorde „In enige fonds, sodanig gestig, word gestort, alle gelde” in subartikel (2) te skrap en hulle te vervang deur die woorde „Enige fonds, sodanig gestig, word gekrediteer met alle betalings”;

(ii) deur in subartikel (4) die woorde „en ander bate” na die woorde „gelde” in die eerste lyn en die woorde „of behorende aan enige fonds” na die woorde „vervat” in die eerste lyn in te voeg, en deur die volgende nuwe sin aan die end van die subartikel by te voeg:

„By die uitvoering van hierdie subartikel word veral bepaal dat die Administrateur mag magtig—

(a) die verkoop van manna in 'n fonds inbetaal te eniger tyd teen 'n prys wat deur hom vastgestel word op voorwaarde dat die opbrings in bedoelde fonds inbetaal word;

(b) die uitdeling in tye van droogte of hongersnood van sodanige manna óf gratis óf op sodanige voorwaardes, as wat hy goed mag ag, aan persone in die gebied woonagtig waar die betrokke fonds in werking is.”

(iii) deur in subartikel (7) die woorde „of die ekwivalent daarvan in natura” na die woorde „sielings” in te voeg.

2. Hierdie Proklamasie het die Ovambolandse Aangeleenthede Wysigingsproklamasie 1941,

**PROCLAMATION  
BY HIS HONOUR DAVID GIDEON CONRADIE,  
ADMINISTRATOR OF SOUTH WEST AFRICA.**

No. 15 of 1941.]

WHEREAS it is desirable further to amend the law making provision for the government of Ovamboland,

NOW THEREFORE under and by virtue of the powers in me vested, I do hereby proclaim, declare and make known as follows:

1. Section *three* of the Ovamboland Affairs Proclamation, 1929 (Proclamation No. 27 of 1929), is hereby amended as follows:

(i) In sub-section (2), the substitution of the words “credited to” for “paid into” in the first line and the word „payments” for “moneys” where the latter occurs for the first time;

(ii) in sub-section (4), the insertion in the first line between the words “moneys” and “contained” of the words “and other assets” and between “in” and “any” of the words “or belonging to”, and the addition at the end of the sub-section of the following new sentence:

“In carrying out the provisions of this sub-section it is particularly provided that the Administrator may authorise—

(a) the sale of millet paid into a Fund at any time at a price to be fixed by him on condition that the proceeds are paid into the said Fund;

(b) the issue in times of drought or famine of such millet either free or upon such conditions as he may deem fit to persons domiciled in the area where the Fund concerned is operative.”;

(iii) in sub-section (7), the insertion after the word “shillings” of the words “or the equivalent thereof in kind.”

2. This Proclamation shall be called “The Ovamboland Affairs Amendment Proclamation, 1941”.

WET OP GENEESHÈRE, TANDARTSE EN APTEKERS,  
NO. 13 VAN 1928.—GEWYSIGDE REGULASIE.

In die uitvoering van die bevoegdheid hom verleen by artikel *nege-en-seventig* van die Wet op Geneeshère, Tandartse en Aptekers, No. 13 van 1928, en na oorleg met die Suid-Afrikaanse Geneeskundige Raad en met die Suid-Afrikaanse Farmaseutiese Raad, het dit die Minister van Volksgesondheid behaag om te bepaal dat, behalwe die uitgawe van 1932 van die „British Pharmacopoeia”, soos erken in gevolge Goewermentskennisgewing No. 406 van 24 Maart 1933 en die byvoegsel tot daardie uitgawe van 1936, soos erken by Goewermentskennisgewing No. 1482 van 24 September 1937, die Tweede Byvoegsel tot die Pharmacopoeia van 1940 vir die doeleindes van daardie artikel van die Wet met ingang van 1 Julie 1941 gebruik moet word.

MEDICAL, DENTAL AND PHARMACY ACT, NO. 13 OF 1928.—AMENDED REGULATION.

The Minister of Public Health, in the exercise of the powers conferred on him by section *seventy-nine* of the Medical, Dental and Pharmacy Act, No. 13 of 1928, and after consultation with the South African Medical Council and South African Pharmacy Board, has been pleased to determine that, in addition to the 1932 edition of the British Pharmacopoeia as recognised in terms of Government Notice No. 406 of the 24th March, 1933, and the 1936 Addendum to that edition as recognised by Government Notice No. 1482 of the 24th September, 1937, the Second Addendum, 1940, to the Pharmacopoeia shall be used for the purpose of that section of the Act with effect from the 1st July, 1941.
