Ek, RICHARD STUTTAFORD, Minister van Handel en Nywerheid, handelende kragtens die bevoegdheid my verleen by Regulasie 3 (1) (f) van die Landsnoodtoestandsregulasies uiteengesit in die Bylae van Proklamasie No. 135 van 1941 (Oorlogsmaatregel No. 27 van 1941), en op aanbeveling van die Raad van Beheer van Landsvoorrade verbied hierby dwarsdeur die Unie en die Mandaatgebied Suidwes-Afrika, die lewering van petrol deur enige petrolhandelaar aan enige persoon op enige Sondag en op enige Saterdag voor 6 uur v.m. of na 12 uur middag en op enige ander weekdag voor 6 uur v.m. en na 10 uur n.m.; met dien verstande dat hierdie verbod nie van toepassing is op die lewering van petrol aan enige petrol-kleinhandelaar deur enige petrol-groothandelaar tussen die ure 12 uur middag op Saterdag 31 Januarie 1942 en 6 uur v.m. op Maandag 2 Februarie 1942 nie.

I, RICHARD STUTTAFORD, Minister of Commerce and Industries, acting under the powers conferred upon me by Regulation 3 (1) (f) of the National Emergency Regulations set forth in the Annexure to Proclamation No. 135 of 1941 (War Measure No. 27 of 1941), and on the recommendation of the National Supplies Control Board, do hereby prohibit, throughout the Union and the Mandated Territory of South West Africa, the supply of petrol by any dealer in petrol to any person on any Sunday and on any Saturday before 6 o'clock a.m. or after 12 noon, and on any other weekday before 6 o'clock a.m. and after 10 o'clock p.m.; provided that this prohibition shall not apply to the supply of petrol by any wholesale dealer in petrol to any retail dealer in petrol between the hours of 12 noon on Saturday the 31st January, 1942, and 6 a.m. on Monday the 2nd February, 1942.

Government Notice No. 1672 of the 24th November, 1941, is hereby withdrawn.
