PROCLAMATION

BY HIS HONOUR DAVID GIDEON CONRADIE,
ADMINISTRATOR OF SOUTH WEST AFRICA.

*No. 6 of 1943.]

WHEREAS it is desirable to amend further the law relating to the administration of natives;

NOW, THEREFORE, under and by virtue of the powers in me vested, I do hereby proclaim, declare and make known as follows:—

1. Section *sixteen* of the Native Administration Proclamation, 1922 (Proclamation No. 11 of 1922), is hereby amended by the addition of the following words at the end thereof:—

“Any coloured person who resides in such a reserve shall, during such residence, be considered as a native for the purposes of this proclamation and any regulations issued thereunder.”

2. This proclamation shall be called the Native Administration Amendment Proclamation, 1943.

SOUTH AFRICAN MEDICAL COUNCIL.—RULES REGARDING REGISTRATION OF ADDITIONAL QUALIFICATIONS.

The Minister of Public Health, in exercise of the powers conferred on him by sub-section (4) of section *ninety-four* of the Medical, Dental and Pharmacy Act, No. 13 of 1928, has approved of the rules made by the South African Medical Council under sub-section (2) (h) of the said section of the Act and published under Government Notice No. 1371 of 21st August, 1931, as amended, being further amended by the addition of the following diploma which may be registered as an additional qualification under section *thirty-three* of Act No. 13 of 1928:—

CATTLE IMPROVEMENT REGULATIONS: AMENDMENT OF.

The Administrator has been pleased under and by virtue of the powers in him vested by section 13 of the Cattle Improvement Consolidation Ordinance, 1941 (Ordinance No. 14 of 1941), to amend the Regulations published under Government Notice No. 87 of the 2nd June, 1941, by the addition of the following new regulations:—

11. The Administrator may grant a loan to an owner of stock for the purpose of paying for, in full or in part, a bull to replace a bull disapproved of by a Board, provided that:—

- Board has so recommended;
- the Administrator is satisfied that the applicant is not financially in a position to purchase a suitable bull without such assistance, and
- the bull to be purchased has been approved of by a Board or is a registered bull.

12. Application for a loan shall be made in the form specified in the annexure hereto. Any person who wilfully makes a false statement in such application shall be guilty of an offence and liable on conviction to a fine not exceeding £25 or in default of payment to imprisonment for a period not exceeding 3 months.

13. The loan shall be repayable, without interest, in equal half-yearly instalments over a period of three years from the date of payment thereof.

14. The first instalment shall become due and payable at the expiration of six months from the date of payment of the loan and subsequent instalments shall become due and payable every six months thereafter.

15. In the event of an owner failing to pay the instalments on the due dates, interest at the rate of six per centum per annum shall become payable thereon from the due date to the date of payment.

16. All payments shall be made at the office of the Magistrate of the district in which the owner resides, or at such other places as the Administrator may direct.

BEESTEVEEBETERINGSREGULASIES: WYSIGING VAN.

Dit het die Administrateur behaag om, op grond van en kragtens die bevoegdheide hom verleen deur artikel 13 van die Beesteverbeterings-Konsolidasieordonnansie 1941 (Ordonnansie No. 14 van 1941), die regulasies, ingevolge Goewermentskennisgewing No. 87 van 2 Junie 1941 afgekondig, deur die byvoeging van die volgende nuwe regulasies te wysig:—

11. Die Administrateur kan 'n lening aan 'n eienaar van vee toestaan vir die doel om, geheel of gedeeltelik, vir 'n bul te betaal, ten einde 'n bul, wat deur 'n Raad afgekeur is te vervang, met dien verstande dat:—

- 'n Raad dit aanbeveel het;
- die Administrateur daarvan oortuig is dat die applikant se geldelike toestand nie sodanig is om 'n geskikte bul sonder sodanige hulp te koop nie; en
- die bul wat gekoop word deur 'n Raad goedgekeur of 'n geregistreerde bul is.

12. Aansoek om 'n lening moet op die wyse, in die aangehegte bylae uiteengesit, geskied. Iemand, wat 'n valse verklaring in so 'n aansoek doen is skuldig aan 'n oortreding en by skuldigbevinding onderhewig aan 'n boete van hoogstens £25 of, by wanbetaling, aan gevangenisstraf vir 'n tydperk van hoogstens 3 maande.

13. Die lening moet oor 'n tydperk van drie jaar vanaf die datum van die betaling daarvan in gelyke halfjaarlikse paaieimente sonder rente terugbetaal word.

14. Die eerste paaieiment is verskuldig en betaalbaar na die afloop van ses maande vanaf die betaaldag van die lening en daaropvolgende paaieimente is elke ses maande daarna verskuldig en betaalbaar.

15. Ingeval 'n eienaar versuim om die paaieimente op die vervaldae te betaal, is rente teen ses persent per jaar daarop vanaf die vervaldag tot die dag van betaling betaalbaar.

16. Alle betalings moet geskied by die kantoor van die Magistraat van die distrik, waarin die eienaar woonagtig is, of op sodanige ander plekke as wat die Administrateur mag gelas.

17. Until the amount of the loan with any interest which may become due under the provisions of regulation 15, shall be fully paid, the bull(s) purchased shall remain the sole and absolute property of the Administrator and the ownership thereof shall not pass to or vest in the owner, but upon payment of the last instalment and any interest due, the said bull(s) shall become the sole and absolute property of the owner.

18. Until the said bull(s) shall have become the property of the owner he shall not be entitled to sell, let, pledge, or in any other way alienate, encumber or part with the possession of the said bull(s).

19. Any loss whether due to death, straying, theft or any other cause which may occur to the said bull(s) shall fall upon the owner, notwithstanding that the ownership of the bull(s) shall, at the time of such loss, be vested in the Administrator.

20. Upon request by the Board the owner shall be obliged to produce the said bull(s) at all reasonable times for the purpose of inspection thereof by any person acting on behalf of a Board.

21. If an owner shall fail to pay any instalments on the due date, or any interest due or if he shall commit any breach of regulations 18 and 20 the Administrator shall be entitled forthwith to resume possession of and to remove the said bull(s) without recourse to law, or the Administrator may apply to any court of competent jurisdiction for an order restoring possession of the said bull(s) to the Administrator, and the owner shall, on such resumption of possession and removal or on such restoration, have no claim whatsoever to a refund of any sum or sums already paid by him by way of instalments and interest, but shall nevertheless remain liable for all arrear instalments plus any interest due thereon as provided in paragraph 15 hereof, and for all damages which the Administrator may sustain by reason of the breach of these regulations.
