SO IS DIT dat ek, op grond van en kragtens die bevoegdheede my verleen, hiermee proklameer, verklaar en bekendmaak, soos volg:—

1. Paragraaf (b) van subartikel (1) van artikel drie-en-sestig van die Oordonnansie op die Oortreding van Diere, 1939 (No. 16 van 1939), word hiermee herroep en deur die volgende nuwe paragraaf vervang:—

„(b) weifooie ten opsigte van daardie dier vir die hele tydperk van die oortreding, gereken vanaf die datum, waarop die in subartikel (1) van artikel twee-en-sestig vermelde kennisgewing of rapport aan die posbevelhebber afgelewer of uitgebring is, teen die volgende tarief:

Skaapramme of bokramme bo die ouderdom van nege maande:	3d. per dag, per stuk.	1½d. per dag, per stuk.
Ander skape of bokke:	1d. per dag, per stuk.	½d. per dag, per stuk.

NADEMAAL dit wenslik is om die bepalings in die wet betreffende wapens en ammunisie, wat van die houer van 'n lisensie om 'n geweer te besit vereis om sodanige lisensie jaarliks te hernu, te herroep;

SO IS DIT dat ek, op grond van en kragtens die bevoegdheede my verleen, hiermee proklameer, verklaar en bekendmaak, soos volg:—

1. In hierdie Proklamasie beteken „die Hoofproklamasie” die Wapens en Ammunisie Proklamasie 1938 (No. 28 van 1938), soos gewysig deur die Wapens en Ammunisie Aanvullingsproklamasie, 1938 (No. 32 van 1938), die Wapens en Ammunisie Wysigingsproklamasie 1940 (No. 20 van 1940) en die Wapens en Ammunisie Wysigingsproklamasie 1941 (No. 9 van 1941).

2. Subartikel (9) van artikel vier van die Hoofproklamasie word hiermee herroep.

3. Paragraaf (d) van artikel vyf van die Hoofproklamasie word hiermee herroep.

4. Die Wapens (Verlenging van Lisensies) Proklamasie 1940 (No. 3 van 1940) en die Wapens (Verlenging van Lisensies) Proklamasie 1941 (No. 25 van 1941) word hiermee herroep.

(No. 10 of 1927), shall be deemed to have been a valid consent for the purpose of section four of the said Ordinance, notwithstanding that such mother was a minor at the time when she so gave such consent, and that she was not assisted thereto by her parent or guardian.

3. This Proclamation shall be called the Adoption of Children Amendment Proclamation, 1943.

WHEREAS it is desirable to amend the law relating to the Trespass of Animals;

NOW THEREFORE, under and by virtue of the powers in me vested, I do hereby proclaim, declare and make known as follows:—

1. Paragraph (b) of sub-section (1) of section sixty-three of the Trespass of Animals Ordinance, 1939 (No. 16 of 1939), is hereby repealed and the following new paragraph substituted therefor:—

“(b) grazing fees in respect of that animal for the whole period of the trespass, reckoned from the date on which the notice or report referred to in sub-section (1) of section sixty-two was delivered or made to the post commander, at the following rates:—

	If the trespass occurred on land enclosed with a sufficient fence.	If the trespass occurred on land not enclosed with a sufficient fence.
Bulls or stallions (other than mules) over eighteen months of age:	6d. per day, per head.	3d. per day, per head.
Other cattle, horses, mules, or asses or ostriches or pigs:	3d. per day, per head.	1½d. per day, per head.
Sheep rams or goat rams over nine months of age:	3d. per day, per head.	1½d. per day, per head.
Other sheep or goats:	1d. per day, per head.	½d. per day, per head.

2. This Proclamation shall be called the Trespass of Animals Amendment Proclamation, 1943.

WHEREAS it is desirable to repeal, in the law relating to Arms and Ammunition, the provisions which require the holder of a licence to possess a rifle to renew such licence annually;

NOW THEREFORE, under and by virtue of the powers in me vested, I do hereby proclaim, declare and make known as follows:—

1. In this Proclamation “the Principal Proclamation” means the Arms and Ammunition Proclamation, 1938 (No. 28 of 1938), as amended by the Arms and Ammunition Supplementary Proclamation, 1938 (No. 32 of 1938), the Arms and Ammunition Amendment Proclamation, 1940 (No. 20 of 1940), and the Arms and Ammunition Amendment Proclamation, 1941 (No. 9 of 1941).

2. Sub-section (9) of section four of the Principal Proclamation is hereby repealed.

3. Paragraph (d) of section five of the Principal Proclamation is hereby repealed.

4. The Arms (Extension of Licences) Proclamation, 1940 (No. 3 of 1940), and the Arms (Extension of Licences) Proclamation, 1941 (No. 25 of 1941), are hereby repealed.
