PROCLAMATION

BY HIS HONOUR PETRUS IMKER HOOGENHOUT,
ADMINISTRATOR OF SOUTH WEST AFRICA.

No. 6 of 1947.]

WHEREAS it is desirable temporarily to extend the time for payment of motor licence duty:

NOW THEREFORE under and by virtue of the powers in me vested, I do hereby proclaim, declare and make known as follows:—

1. Notwithstanding the provisions of sub-section (5) of Section two of the Motor Vehicle and Wheel Tax Ordinance, 1937 (Ordinance No. 17 of 1937), as inserted by section one of the Motor Vehicle and Wheel Tax Amendment Ordinance, 1942 (Ordinance No. 12 of 1942), the owner of a motor vehicle who held a licence under that Ordinance in respect of such motor vehicle for the period ended 31st March, 1947, may renew such licence not later than the 31st May, 1947, without payment of penalty. Provided that if any such licence is renewed after 31st May, 1947, there shall be paid, in addition to the licence fee, a penalty at the rate of 5 per cent. of the motor licence fee for each month or part of a month for which the owner is in default.

2. This Proclamation may be called the Motor Vehicle and Wheel Tax Amendment Proclamation, 1947.

NADEMAAL dit wenslik is om die tydperk waarin die betaling van gelde vir motorlisensies moet geskied, tydelik te verleng;

SO IS DIT dat ek, kragtens die bevoegdheid my verleen hierby soos volg proklameer, verklaar en bekend maak:—

1. Nieteenstaande die bepalings van sub-artikel (5) van artikel twee van die Ordonnansie op Motorvoertuie en Wielbelasting 1937 (Ordonnansie 17 van 1937), soos ingevoeg deur artikel een van die Wysigingsordonnansie op Motorvoertuie en Wielbelasting 1942 (Ordonnansie 12 van 1942), mag die eienaar van 'n motorvoertuig wat 'n lisensie kragtens daardie Ordonnansie ten opsigte van sodanige voertuig vir die tydperk geëindig 31 Maart 1947 gehou het, sodanige lisensie nie later nie as 31 Mei 1947 sonder betaling van boete, hernu: Met dien verstande dat indien enige sodanige lisensie na 31 Mei 1947 hernu word, daar bo en behalwe die lisensie-gelde, 'n boete van 5 persent van die motorlisensiegeld vir elke maand of gedeelte van 'n maand wat die eienaar agterstalling is, betaal moet word.

2. Hierdie Proklamasie heet die Wysigingsproklamasie op Motorvoertuie en Wielbelasting, 1947.
