ANNEXURE.

REGULATION.

AMENDMENT OF NATIONAL SECURITY REGULATION 30  
(WAR MEASURE No. 4 OF 1941).

Regulation 30 of the National Security Regulations promulgated by Proclamation No. 20 of 1941, dated the 3rd day of February, 1941, as amended from time to time, is hereby amended—

- (a) by the deletion in sub-regulation (1) of the words "who was domiciled or resident in the Union or the Mandated Territory at the time when he was attested for service with those forces";
- (b) by the substitution in the said sub-regulation for the words "the Territory" of the words "the Mandated Territory";
- (c) by the substitution in the said sub-regulation for the words "so attested", wherever they occur, of the words "attested for service with those forces";
- (d) by the deletion in sub-regulation (2) of the words "who was domiciled or resident in the Union or the Mandated Territory at the time when he was attested for service with those forces";
- (e) by the substitution in the said sub-regulation for the words "the Territory" of the words "the Mandated Territory";
- (f) by the substitution in the said sub-regulation for the words "so attested", wherever they occur, of the words "attested for service with those forces"; and
- (g) by the addition at the end of the said regulation of the following sub-regulation:—

"(9) For the purposes of this regulation any member of the land, air or naval forces of the Union, who was not domiciled or resident in the Union or the Mandated Territory at the time when he was attested for service with those forces, shall be deemed to have been resident, at the time when he was so attested, at the place in the Union where the headquarters of the forces concerned is situated."

- (a) deur die woorde „wat in die Unie of die Mandaatgebied gedomiliseer of woonagtig was ten tyde van sy attestasie vir diens in genoemde staatsmag" in subregulasie (1) te skrap;
- (b) deur die woorde „die gebied" in voormalde subregulasie te vervang deur die woorde „die Mandaatgebied";

## ANNEXURE.

## AMENDMENT OF EMERGENCY FINANCE REGULATIONS.

## CONTROL OF CAPITAL ISSUES.

The regulations set forth in the Annexure to War Measure No. 119 of 1942 (Proclamation No. 266 of 1942), as amended by War Measure No. 9 of 1943 (Proclamation No. 30 of 1943) and by War Measure No. 14 of 1947 (Proclamation No. 59 of 1947) are hereby further amended by the substitution for sub-regulation (2) of regulation 14 of the following sub-regulation:-

"(2) The Minister of Finance may from time to time by notice in the *Gazette*-

- (a) exempt particular classes of issuers of capital, either generally, or in respect of particular classes of issues of capital, from the operation of sub-regulation (1); or
- (b) increase, either generally or in respect of particular classes of issues or issuers of capital, the aggregate exemption limits of five thousand pounds prescribed in sub-regulation (1)

and may by similar notice withdraw any such aforementioned notice or reduce to not less than five thousand pounds any exemption limit prescribed in any such aforementioned notice as the case may be."

## BEHEER OOR KAPITAALUITGIFTE.

Die regulasies wat in die Aanhangsel tot Oorlogsmaatregel No. 119 van 1942 (Proklamasie Nr. 266 van 1942), soos gewysig by Oorlogsmaatregel No. 14 van 1943 (Proklamasie Nr. 30 van 1943) en by Oorlogsmaatregel No. 14 van 1947 (Proklamasie Nr. 59 van 1947), uiteengesit is, word hierby verder gewysig deur die vervanging van subregulasie (2) van regulaasie 14 deur onderstaande subregulasie:-

"(2) Die Minister van Finansies kan van tyd tot tyd by kennisgewing in die *Stataakoorant*-

(a) spesifieke soorte uitgears van kapitaal, of in die algemeen of met betrekking tot spesifieke soorte uitgiforme van kapitaal, vrystel van die bepalings van subregulasie (1); of

(b) die vrystellingsperke van vyfduisend pond, soos in subregulasie (1) aangegee, of in die algemeen of met betrekking tot spesifieke soorte uitgiforme van uitgears van kapitaal, verhoog,

en kan by soortgelyke kennisgewing enige sodanige voorrmelde kennisgewing terugtrek of enige vrystellingsperk wat in enige sodanige normale kennisgewing aangegee is, na gelang van die geval, na 'n bedrag van nie minder as vyfduisend pond nie, verminder."

## BYLAE.

## DIREKTEUR VAN VOEDSELVOORRADE EN DISTRIBUSIE.

*Grassoorte*.—Rys, heel of gebreek en alle eethare rysooprodukte met insbjag van stywel en mel en alle rysooprodukte wat vir dierlike voedsel bedoel is; gars, lawer en rog en die produkte daarvan.

**NOTE.**—Permits issued by the Department of Agriculture are required for the importation of wheat and wheat products, maize and maize products.

**Cocoa.**—Cocoa beans raw, nips and shells; cocoa butter; unsweetened chocolate couverture.

**Fats and Oils.**—Fatty acids; fish oils; oils and fats, animal and vegetable; oil seeds, including groundnuts for edible purposes; soap and substances containing soap.

**Fish.**—(1) Salted cod, haddock, hake, cusk, pollock, saithe and ling; (2) canned (tinned) salmon, pilchards, sardines, herrings, silders, alewives, tuna, mackerel, crayfish and ground fish (cod, haddock, hake, cusk, pollock, saithe and ling).

**Meat.**—Fresh, frozen, pickled, salted, smoked, canned, and dehydrated meat (excluding fresh and frozen poultry, rabbits and venison).

**Pulses.**—Dry beans, dry peas, dry lentils.

#### CONTROLLER OF JUTE GOODS.

Jute products, whether in the piece or manufactured; bags, woolpacks and pockets, whether new or second-hand made from Jute, cotton, linen or any other fibre and suitable as containers for the conveyance of grain or grain products, wool, fruit, vegetables, fertilizers or coal; sewing and binding twine; paper lined jute or fibre material; excluding—

(a) such other manufactured commodities containing jute as a base or ingredient such as carpets, linoleums, jute webbing, jute gasketing, jute sashcord and jute furnishing fabrics excepting hessian;

(b) goods packed in jute or hessian covers and/or containers in respect of such covers or containers.

**NOTE.**—In terms of Government Notice No. 2019 of the 20th September, 1946, the above-mentioned goods are subject to import permit irrespective of the country of origin.

#### EXPLANATORY NOTES:

(1) The effect of this notice is to amend the previous list of articles requiring import permits under the National Emergency Regulations. Goods not shown in the above Schedule and those specifically excluded under the heading Controller of Jute Goods may be imported without permits previously required under these regulations.

(2) It should be noted that it is required by the Customs Department that importers who claim admission of permit-free goods must make and subscribe to the following certificates on the Customs Bill of Entry: "I certify that the goods marked X are not subject to import permit." (Signature).....

#### IMPORTANT NOTES:

Certificates of Essentiality for the importation of the following quota goods allocated to the Union by the Union Kingdom as still required and applications therefor should be submitted as heretofore:—

1. Leather.
2. Terneplate and tinplate.

#### CONTROL OF INDUSTRIAL CHEMICALS AND NON-FERROUS MATERIALS.

I, Gabriel Daniel Louw, Controller of Industrial Chemicals and Non-Ferrous Materials, on behalf of the Minister of Economic Development, and by virtue of the authority invested in me by Government Notice No. 84 of 10th January, 1947, and War Measure No. 146 of 1942, as amended, do hereby order as follows:—

#### PART I.—GENERAL.

1. In this notice the following words and expressions have the meanings assigned to them unless the context otherwise requires:—

"Controller" means the Controller of Industrial Chemicals and Non-ferrous Materials, whose address is 216 Central Street, Pretoria;

"Union" means the Union of South Africa and includes the Mandated Territory of South West Africa and the port and settlement of Walvis Bay.

2. The headings of the various parts of the regulations form part of the regulations.

3. The regulation shall apply throughout the Union.

4. Notwithstanding anything contained in these regulations the Controller may in such circumstances and to such extent as he may deem fit grant exemption to any person from all or any of the provisions of these regulations.

Ek, Gabriel Daniel Louw, Kontroleur van Nywerheidschemikalië en Nie-ysterhoude Stowwe, gelas hierby naamens die Minister van Ekonomiese Ontwikkeling en kragtens die bevoegdheid my verleen by Goewernementskennisgewing No. 84 van 10 Januarie 1947, en Oorlogsmaatregel No. 146 van 1942, soos gewysig, as volg:—

#### DEEL I.—ALGEMEEN.

1. In hierdie kennisgewing het die onderstaande woorde en uitdrukkinge die betekenis wat daaraan geheg word, tensy uit die samehang anders blyk:—

"Kontroleur", Kontroleur van Nywerheidschemikalië en Nie-ysterhoude Stowwe wie se adres Sentraalstraat 216, Pretoria is.

"Unie", die Unie van Suid-Afrika, met inbegrip van die Mandategebied Suidwes-Afrika en die hawe en nedersetting Walvisbaai.

2. Die opskrifte van die verskillende afdelings van die regulasies vorm deel van die regulasies.

3. Die regulasies sal regdeur die Unie van krag wees.

Provided that no return is required from any such person who holds or handles quantities of the said chemicals which amount to less than 200 lbs. of each during any period of twelve months.

(ii) All quantities shall be expressed in tons of 2,000 lbs.

(iii) Returns must be submitted in respect of each month and must reach the Controller not later than the 10th of the month following the month in respect of which the return is made.

(iv) Persons holding stocks at more than one place shall make separate returns for each such place.

In view of the foregoing exemption all conditions relating directly or indirectly to fixed property which the Treasury has at any time imposed or included in any of its consents, under Regulation 14, to the issue of capital, are hereby withdrawn and cancelled.

**EXPLANATORY NOTES.**

(N.B.)—The Treasury appends the following explanatory notes for general information:-

1. The effects of the above Government Notice are that from the date thereof and until further notice all companies and persons, other than local authorities, may make issues of capital for any purpose whatsoever without application to or consent of the Treasury and that all conditions in respect of fixed property which the Treasury has hitherto imposed in any of its consents, under regulation 14, to any issue of capital, now fall away.

2. It is emphasised, however, that the prohibitions in regulation 13—see Proclamation No. 59 in Gazette No. 3775 of the 7th March, 1947—on the issue of bearer shares or bearer options and on the extension of the currency period of existing bearer options, are not affected by the aforementioned exemption and remain in full force.

3. Companies or persons in the Union or South West Africa who may desire to issue or raise capital in other countries are responsible for complying with any requirements which may there be in force. Any inquiries or applications which may be found necessary in such cases should be made, not to or through the Union Treasury, but to the authorities of the country concerned, either direct or through applicant's agent in such other country. In the case of capital to be issued or raised in the United Kingdom, applications are dealt with by the Capital Issues Committee of the British Treasury.
