**ALTERATION OF POLLING STATION IN THE ELECTORAL DIVISION OF GOBABIS.**

Under and by virtue of the powers vested in me by paragraph *thirty-seven* of Part III of the Schedule to the South West Africa Constitution Act, 1925 (Act No. 42 of 1925), I do hereby make known that Government Notice No. 103, which is dated the second day of May, 1932, is hereby amended by deleting the words "(Polling Station Springboklaagte)" appearing in paragraph *two* of the Schedule annexed thereto and substituting therefor the words "(Polling Station Graswereld No. 272)".

**POLLING STATIONS.**

The Administrator has been pleased, in terms of paragraph *thirty-seven* of Part III of the Schedule to the South West Africa Constitution Act, 1925 (Act No. 42 of 1925), as amended from time to time, to appoint the places described in the third column of the Schedule annexed hereto to be the polling stations of the Polling Districts defined by Government Notice No. 103, dated the 2nd May, 1932, as amended, and described in the first and second columns of the said Schedule, opposite to the description of each such polling station respectively for the purpose of the poll to be taken for the election of an elective member of the Fifth Legislative Assembly for the Electoral Division of Gobabis, which in terms of Government Notice No. 181 of the 2nd June, 1947, shall take place on Wednesday the 23rd day of July, 1947.
