Portion Closed:

The road described as Trunk Road No. 1 — Section 4 in Schedule II of Proclamation No. 29 of 1953.

From a point on Trunk Road No. 1 — Section 4 on the southern boundary of the farm Rehoboth Dorpsgrond No. 302 generally north-northwestwards via the farm Rehoboth Dorpsgrond No. 302, to the southern limit of the surveyed Erven of the Township of Rehoboth.

The road described as Trunk Road No. 1 — Section 5 in Schedule II of Proclamation No. 29 of 1953.

From a point on Rehoboth Dorpsgrond No. 302 in the district of Rehoboth at the northern limit of the surveyed Erven of the Township of Rehoboth, generally northwards via the farms Rehoboth Dorpsgrond No. 302, Geluk Wes No. 255, Portion 1 of Geluk Wes No. 255 and Naruchas No. 254 to a point on the northern boundary of the lastmentioned farm.
