PUBLIC ROAD No. 2606:

From a point on Main Road No. 64 on the farm Vaalhoek No. 397 generally southeastwards in the district of Outjo via the farm Vaalhoek No. 397 to connect with Public Road No. 2605 at a point near the homestead on the said farm.

PUBLIC ROAD No. 2607:

From a point on Main Road No. 64 on the farm Dieprivier No. 393 generally east-southeastwards in the district of Outjo via the farms Dieprivier No. 393, the north-eastern corner of Uitskot No. 395 and No. 396 known as Middelplaas to connect with District Road No. 2610 at a point on the lastmentioned farm.

PUBLIC ROAD No. 2608:

From a point on District Road No. 2610 on the farm Omborombonga No. 403 generally east-southeastwards in the district of Outjo via the farms Omborombonga No. 403 and Moedhou No. 402 to a point on the lastmentioned farm; thence generally east-northeastwards via the farms Moedhou No. 402 and Orusewa No. 1 to connect with Public Road No. 2358 at a point on the lastmentioned farm.

PUBLIC ROAD No. 2614:

From a point near the homestead on the farm No. 406 generally westwards in the district of Outjo via the farms No. 406 and No. 499 to a point near the homestead on the lastmentioned farm.

PUBLIC ROAD No. 2615:

From a point on District Road No. 2612 on the farm No. 500 generally north-northwestwards in the district of Outjo via the farms No. 500 and No. 478 to a point on the lastmentioned farm; thence generally northwestwards via the farms No. 478 and No. 480 to connect with District Road No. 2628 at a point on the lastmentioned farm.
