ORDINANCE

To apply a further sum not exceeding sixty-six thousand two hundred and ninety-five pounds towards the service of the Territory of South West Africa for the financial year ending on the thirty-first day of March, 1956.

(Assented to 11th April, 1956.)

(Afrikaans tekst signed by the Administrator.)

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa as follows:—

1. The Administration Account of the Territory of South West Africa is hereby charged with the sum of sixty-six thousand two hundred and ninety-five pounds on the Revenue Account to meet certain expenditure over and above the amounts appropriated for the service of the financial year ending on the 31st March, 1956, as specified in Ordinance 7 of 1955.

2. The money appropriated by this Ordinance shall be applied to the services detailed in the Schedule hereto and more particularly specified in the Second Additional Estimates of Expenditure to be defrayed from Revenue Funds (S.W.A. 2—1956) as approved by the Legislative Assembly.

3. This Ordinance shall be called the Second Additional Appropriation (1955/56) Ordinance, 1956.

ORDINANCE

To amend the Motor Vehicle and Wheel Tax Ordinance, 1937 (Ordinance 17 of 1937), to provide for exemptions under the definition of motor vehicles, the amendment of fees for the licensing of motor vehicles and for the repeal of wheel tax in respect of motor vehicles.

(Assented to 11th April, 1956.)

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa as follows:—

1. Section one of the Motor Vehicle and Wheel Tax Ordinance, 1937, hereinafter referred to as the principal Ordinance, is hereby amended—

1. Die Administrasierekening van die Gebied Suidwes-Afrika word hiermee belas met die bedrag van ses-en-sestig duisend twee honderd vyf-en-negentig pond op die Inkomsterkening tot dekking van sekere uitgawes bo en behalwe die bedrag beskikbaar gestel vir die diens van die boekjaar wat op 31 Maart 1956 eindig, soos in Ordonnansie 7 van 1955 vermeld is.

2. Die geld wat deur hierdie Ordonnansie beskikbaar gestel word, moet aangewend word vir die dienste in besonderhede vermeld in die Bylae tot hierdie Ordonnansie en omstandiger uiteengesit in die Tweede Bykomende Begroting van Uitgawe wat gedek moet word uit Inkomste-fondse (S.W.A. 2—1956) soos deur die Wetgewende Vergadering goedgekeur.

ORDONNANSIE

Ter wysiging van die Ordonnansie op Motorvoertuie Wiebelasting 1937 (Ordonnansie 17 van 1937) voorsiening te maak vir vrystellings van die woord-bepaling van „motorvoertuig”, vir die wysiging van die lisensiering van motorvoertuie en vir herroeping van die wiebelasting op motorvoertuie.

(Goedgekeur 11de April 1956.)

(Afrikaanse teks deur die Administrateur geteken.)

Die Wetgewende Vergadering van die Gebied Suidwes-Afrika VERORDEN:—

1. Artikel een van die Ordonnansie op Motorvoertuie en Wiebelasting 1937 (hierna heet dit die hoofordonnansie) word hierby gewysig—

by the substitution of the words "by a farmer in connection with his farming operations" for the words "to haul agricultural implements" in paragraph (ii) of the definition of "motor vehicle"; by the substitution of the words "by a farmer in connection with his farming operations" for the words "in farming operations" in paragraph (iv) of the definition of "motor vehicle"; and by the deletion of paragraph (d) of the definition of "vehicle".

2. The following sub-section is hereby substituted for section (2) of section two of the principal Ordinance:—

(2) The licence fee shall be as follows:—

Provided that in regard to any motor vehicle which is self-propelled by power other than mechanical power produced by the use of petrol or electrical power the licence fees payable shall be fifty percent more than the amounts hereinbefore specified, less an amount of fifteen shillings: Provided further that the licence fee in respect of motor vehicles with more than four wheels shall be increased by 7/6 for every wheel in excess of four.

3. Sub-section (1) of section twenty-two of the principal Ordinance is hereby amended by the insertion of the words "excluding a motor vehicle" after the word "vehicle" where it appears for the first time.

4. This Ordinance shall be called the Motor Vehicle Wheel Tax Amendment Ordinance, 1956, and shall come into operation from the 1st day of April, 1956.

Met dien verstande dat die lisensiegelde ten opsigte van 'n motorvoertuig wat aangedryf word deur enige soort elektriese krag buiten meganiese krag wat met petrol of elektrisiteit aangevoer word, vyftig persent hoër is as die bedrag wat hierbo aangegee word, min die bedrag van vyftien sjillings: Met dien verstande voorts dat die lisensiegelde ten opsigte van motorvoertuie wat meer as vier wiele het, verhoog word met 7/6 vir elke wiel meer as vier.

3. Sub-artikel (1) van artikel twee-en-twintig van die hoofordonnansie word hierby gewysig deur die woorde „buiten 'n motorvoertuig" in te voeg na die woord „voertuig" waar dit vir die eerste keer voorkom.

4. Hierdie Ordonnansie heet die Wysigingsordonnansie op Motorvoertuie en Wielbelasting 1956 en tree in werking op die eerste dag van April 1956.

ORDINANCE

To amend the Fishing Industry Levy Imposition Ordinance, 1950.

(Assented to 11th April, 1956.)
(English text signed by the Administrator.)

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa as follows:—

1. Section two of the Fishing Industry Levy Imposition Ordinance, 1950, is hereby amended by the substitution for paragraph (a) of sub-section (2) of the following paragraph:—

“(a) impose a levy at different rates in respect of the different categories of fishermen as defined in section one or different species of fish.”

2. This Ordinance shall be called the Fishing Industry Levy Imposition Amendment Ordinance, 1956.

ORDINANCE

To add certain land to the Waterberg East Native Reserve.

(Assented to 11th April, 1956.)
(English text signed by the Administrator.)

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa, as follows:—

1. (1) On a date to be fixed by the Administrator by Proclamation in the *Official Gazette*, the Crown land comprising the farm Middelbult 331, situate in the district of Otjiwarongo, in extent 6,322 hectares 1,499 square metres, and a certain triangular piece of land in the same district bordering on the southern boundary of the Waterberg East Native Reserve, in extent 3,361 hectares 3,145 square metres, shall be added to the said Reserve for the sole use and occupation of natives, subject to the excision from the Eastern Native Reserve, situate in the district of Gobabis, of a piece of land in extent 11,683 hectares 4,644 square metres, as Crown land in lieu thereof.

(2) The land added to the Waterberg East Native Reserve in terms of sub-section (1), shall for all purposes form part of this Reserve.

(3) Every person who may be concerned in the transaction authorised by sub-section (1) may do all such acts as are necessary to give effect thereto.

2. This Ordinance shall be called the Native Reserves Ordinance, 1956.

Ter wysiging van die Ordonnansie op die Viswywerheidsheffing 1950.

(Engelse teks deur die Administrateur geteken.)

Die Wetgewende Vergadering van die Gebied Suidw-Afrika VERORDEN:—

1. Artikel twee van die Ordonnansie op die Viswywerheidsheffing 1950 word hierby gewysig deur die vanging van paragraaf (a) van sub-artikel (2) deur onderstaande paragraaf:—

“(a) ’n heffing op lê teen verskillende tariewe ten sigte van die verskillende klasse van vissers soos artikel een bepaal, of ten opsigte van verskillende soorte vis;”

2. Hierdie Ordonnansie heet die Wysigingsordonnansie op die Viswywerheidsheffing 1956.

Ter byvoeging van bepaalde grond by die natuurereservaat Waterberg-Oos.

(Goedgekeur 11de April 1956.)
(Engelse teks deur die Administrateur geteken.)

Die Wetgewende Vergadering van die Gebied Suidw-Afrika VERORDEN:—

1. (1) Op ’n datum wat die Administrateur by proklamasie in die *Offisiële Koerant* bepaal, word die kroongrond bestaande uit die plans Middelbult 331 wat in die distrik Otjiwarongo geleë is en 6,322 hektaar 1,499 vierkante meter beslaan, en ’n bepaalde driehoekige stuk grond in dieselfde distrik wat lê aan die suidelike grens van die natuurereservaat Waterberg-Oos en wat 5,361 hektaar 3,145 vierkante meter beslaan, by die genoemde reservaat gevoeg vir die alleengebruik en -bewoning van natuurlike, onderbewys daaraan dat ’n stuk grond groot 11,683 hektaar 4,644 vierkante meter as kroongrond in die plek daarvan uit Oostelike Natuurereservaat, geleë in die distrik Gobabis, uitgesny word.

(2) Die grond wat ingevolge sub-artikel (1) by natuurereservaat Waterberg-Oos gevoeg word, maak elke opsig deel van hierdie reservaat uit.

(3) Elkeen wat betrokke is by die transaksie van sub-artikel (1) gemagtig word, kan al die nodige doen daaraan gevolg te gee.

2. Hierdie Ordonnansie heet die Ordonnansie Natuurereservate 1956.
