UNDER the powers vested in me by section two of the Referendum Act, 1960 (Act No. 52 of 1960), I hereby determine the fifth day of October, 1960, as the date on which a referendum of the white voters in the Union and South West Africa shall be held for the purpose of ascertaining whether or not those voters are in favour of a republic for the Union.
