FOOT AND MOUTH DISEASE AREAS FOR RESTRICTIONS IN CONNECTION WITH FOOT AND MOUTH DISEASE

The Administrator has been pleased under and by virtue of the powers vested in him by section 27 of the Animal Diseases and Parasites Ordinance, 1959 (Ordinance 34 of 1959), to delete the schedule to Government Notice 233 of the 15th September, 1961, and to substitute the following schedule therefor without prior publication because he is of the opinion that the purpose of these regulations would be defeated by delay.

SCHEDULE

FOOT AND MOUTH DISEASE AREAS FOR RESTRICTIONS IN CONNECTION WITH FOOT AND MOUTH DISEASE

- (i) The magisterial districts of Grootfontein, Tsumeb, Outjo, Otjiwarongo, Omaruru, Okahandja, Karibib, Swakopmund, Windhoek, Gobabis, and Rehoboth.
- (ii) That portion of the magisterial district of Gibeon described as follows:—
