SOUTH AFRICAN DECORATIONS AND MEDALS

Under the powers vested in me by sub-section (4) of section *one hundred and thirty-six* of the Defence Act, 1957 (Act No. 44 of 1957), I hereby declare that—

- (a) those provisions of the applicable Royal Warrants instituting the decorations and medals enumerated in the Schedule hereunder, which prescribe that the reverse of each of those decorations and medals shall bear in relief the Union Coat of Arms surmounted by the Royal Cypher, shall, with effect from the thirtieth day of May, 1961, cease to be of any force or effect;
- (b) with effect from that date, the reverse of each of those decorations and medals shall bear in relief the Coat of Arms of the Republic of South Africa referred to in section *eighteen* of the Republic of South Africa Constitution Act, 1961 (Act No. 32 of 1961); and
- (c) those provisions of the Royal Warrant instituting the Union Medal—Unie-medalje, which designate the medal as the Union Medal—Unie medalje and prescribe that—
 - (i) the obverse of the medal shall consist of the embellished design of the Union Coat of Arms;
 - (ii) on the left and right of the Coat of Arms the word “Union Medal—Unie-medalje” shall be inscribed; and
 - (iii) the reverse of the medal shall bear in relief the Royal Cypher;

shall, with effect from the thirtieth day of May, 1961, cease to be of any force or effect and that with effect from that date, the medal shall be designated “Permanent Force Good Service Medal—Medalje vir Troue Diens in die Staande Mag”, the obverse shall consist of the Coat of Arms referred to in paragraph (b) and the reverse shall bear in relief the words “Vir Langdurige Dienst en Goeie Gedrag—or Long Service and Good Conduct”.

AMENDMENT OF THE REGULATIONS GOVERNING THE AWARD OF THE UNION MEDAL

The State President has been pleased to amend the Regulations Governing the Award of the Union Medal promulgated by Government Notice No. 5311, dated 16th July, 1954, as amended, as follows:—

1. Delete the words “Union medal” in the preamble to the regulations and substitute the words “Permanent Force Good Service Medal” therefor.

2. Delete the words “Union Medal” in regulation 1 and substitute the words “Permanent Force Good Service Medal” therefor.

3. Delete regulation 4 and substitute the following new regulation therefor:—

“4. (a) An officer who, after the date he was appointed to officer rank or while serving in a temporary capacity —

- (i) is convicted by a court martial of any offence, or is convicted by a civil court of any offence of a fraudulent or disgraceful nature; or
- (ii) is convicted of an offence and sentenced to imprisonment without the option of a fine; or
- (iii) is reduced in rank or seniority for an offence or inefficiency; or
- (iv) incurs more than one adverse entry on his conduct sheet, not being any of the entries detailed in sub-paragraves (i) to (iii) of this paragraph,

shall forfeit all previous qualifying service for the medal, and his qualifying service shall be reckoned only from the date of conviction, promulgation of sentence, reduction in rank or seniority, or the second entry in terms of sub-paragraph (iv), as the case may be, whichever is the later.

(b) Notwithstanding the provisions of sub-regulation (a) the medal may be awarded to an officer who, during any period of 18 years qualifying service incurs the following maximum number of adverse entries on his conduct sheet, not being any of the entries detailed in paragraphs (i) to (iii) of sub-regulation (a), namely where, during the qualifying period, he—

- (i) served only as an officer—one such entry; or
- (ii) served as an other rank and as an officer—three such entries, which may include a maximum of one entry while he served as an officer:

Provided that subsequent to the one entry referred to in paragraph (i) or (ii), or the third entry referred to in paragraph (ii) of this sub-regulation, he completes 12 years qualifying service during which no adverse entry whatsoever is recorded on his conduct sheet.”

4. Delete sub-regulation (d) of regulation 5 and—

- (a) substitute the reference “(d)” in sub-regulation (e) by the reference “(c)”;
- (b) renumber sub-regulation “(e)” as “(d)”;
- (c) substitute the words “the fourth entry in terms of sub-regulation (d)” for the words “return to duty from hospitalisation”.

5. Delete regulation 6 and substitute the following new regulation therefor:—

“6. The medal may be awarded to a member other than an officer who, subject to the provisions of regulation 5, during any period of 18 years qualifying service, incurs the following maximum number of adverse entries on his conduct sheet, not being any of the entries detailed in sub-regulations (a) to (c) of regulation 5, namely where, during the qualifying period, he—

- (a) served only as an other rank—three such entries; or
- (b) served as an officer and as an other rank—three such entries, which may include a maximum of one entry while he served as an officer:

Provided that subsequent to the third entry referred to in sub-regulation (a) or (b), or the one entry referred to in sub-regulation (b) of this regulation, he completes 12 years qualifying service during which no adverse entry whatsoever is recorded on his conduct sheet.”

6. In paragraph (b) of regulation 9, delete the comma and the word “intemperance” after the word “misconduct”.

7. Delete regulation 18 and substitute the following new regulation therefor:—

“18. Forfeiture of the medal and clasp thereto may be recommended if the holder—

- (a) is convicted by court martial of any offence or is convicted by a civil court of any offence of a fraudulent or disgraceful nature;
- (b) is convicted of an offence and sentenced to detention;
- (c) pursuant to an offence, is reduced in rank or seniority; or
- (d) subsequent to award of the medal incurs more than the following number of adverse entries

AMENDMENT TO THE REGULATIONS FOR THE PERMANENT FORCE

The State President has been pleased, in terms of paragraph (s) of sub-section (1) of section *eighty-seven* of the Defence Act, 1957 (Act No. 44 of 1957), as amended, to amend the Regulations for the Permanent Force, promulgated by Government Notice No. 171, dated 26th January, 1923, as amended, as follows:—

CHAPTER V

Delete sub-paragraph (1) of paragraph 32 and substitute the following new sub-paragraph therefor:

“(1) An officer will be paid an outfit allowance of R160 on appointment to assist him in the purchase of uniform and personal equipment enumerated in the scale laid down in the instructions for dress: Provided that where the date of termination of service of such officer as a result of his resignation or misconduct, falls within twelve months of his appointment, he shall refund to the State an amount which bears the same ratio to R160 as the unexpired months (a portion of a month shall be considered a full month) bear to twelve months.”
