FOOT AND MOUTH DISEASE AREAS FOR RESTRICTIONS IN CONNECTION WITH FOOT AND MOUTH DISEASE

BEK- EN KLOUSEERGEBIEDE VIR BEPERKINGS IN VERBAND MET BEK- EN KLOUSEER

The Administrator has been pleased under and by virtue of the powers vested in him by section 27 of the Animal Diseases and Parasites Ordinance, 1959 (Ordinance 34 of 1959), to delete paragraph (ii) of the schedule to Government Notice 274 of the 22nd November, 1961, and to substitute the following therefor without prior publication because he is of the opinion that the purpose of these regulations would be defeated by delay.

Dit behaag die Administrateur om kragtens en ingevolge die bevoegdheid hom verleen by Artikel 27 van Ordonnansie op Dieresiektes en Parasiete 1959 (Ordonnansie 34 van 1959) om paragraaf (ii) van die bylae tot Goewermentskennisgewing 274 van 22 November 1961 te skrap en deur die volgende te vervang sonder voorafgaande publikasie omdat hy van mening is dat die doel van die wysiging van die regulasies deur vertraging verydél sou word.

(ii) That portion of the magisterial district of Gibeon described as follows:

(ii) Daardie deel van die landdrostdistrik Gibeon soos volg omskryf:

From the north-western corner beacon of the farm Schadeck 1, generally eastwards along the magisterial district boundary of Gibeon to the north-eastern corner beacon of the farm Oorwinning 460, then southwards along the magisterial district boundary of Gibeon to the south-eastern corner beacon of farm 495, then westwards along the magisterial district boundary of Gibeon to the north-western corner beacon of the farm Asanib 294, then generally northwards along the boundaries of and including the following properties in succession:

Van die noordwestelike hoekbaken van die plaas Schadeck 1, algemeen ooswaarts langs die grens van die landdrostdistrik Gibeon tot by die noord-oostelike hoekbaken van die plaas Oorwinning 460, vandaar suidwaarts langs die grens van die landdrostdistrik Gibeon tot by die suid-oostelike hoekbaken van plaas 495, vandaar weswaarts langs die grens van die landdrostdistrik Gibeon tot by die noord-westelike hoekbaken van die plaas Asanib 294, vandaar algemeen noordwaarts langs die grense van en insluitende die volgende eiendomme na mekaar:

A'Hingas 160, Duncan 233, Wolwekraal 230, Eenzaamheid 225, Langverwacht 222, Teaks Putz 213, Verloorveld 220, Kriess 219, Glencoe 78, Newcastle 218, Gibeon Reserve 76, Rietkuil 30, Narrnkranz 31, Vergeleë 380, farm 36, Uibis 34, Voigtsgrund 24, Klein Garis 23, Adams Rust 17, Nababis 16, Auros West 15, Schadeck 1 to the north-western corner beacon of the last-mentioned farm, being the point of beginning.

A'Hingas 160, Duncan 233, Wolwekraal 230, Eenzaamheid 225, Langverwacht 222, Teaks Putz 213, Verloorveld 220, Kriess 219, Glencoe 78, Newcastle 218, Reserwaat Gibeon 76, Rietkuil 30, Narrnkranz 31, Vergeleë 380, plaas 36, Uibis 34, Voigtsgrund 24, Klein Garis 23, Adams Rust 17, Nababis 16, Auros West 15, Schadeck 1, tot by die noordwestelike hoekbaken van laasgenoemde plaas, wat die beginpunt is.
