

Government Notice 103 of the 1st July, 1964, is hereby withdrawn.

SCHEDULE.

The Dairy Industry Control Board has in terms of sections *ten* and *twelve* of the Ordinance determined that as from the first day of December, 1964, no person shall acquire, sell or dispose of factory milk otherwise than on the basis of both its weight and butterfat content and at a price other than the following fixed prices:—

- (a) 37½ cents per 100 lbs. of milk, plus
- (b) 37 cents per pound of butterfat contained in such milk.
