No. 12 of 1966.]

WHEREAS by sub-section 3 of section *nineteen* of the South West Africa Constitution Act, 1925, of the Parliament of the Republic of South Africa it is provided that the Administrator may from time to time by Proclamation prorogue the Legislative Assembly for the Territory of South West Africa;

AND WHEREAS it is expedient that the Legislative Assembly should be prorogued;

NOW THEREFORE, under and by virtue of the power and authority in me vested, I do by this Proclamation Prorogue the said Legislative Assembly for the Territory of South West Africa until the 29th March, 1966.
