LEVY ON FRESH MILK PURCHASED BY THE WINDHOEK MUNICIPALITY.

HEFFING OP VARS MELK AANGEKOOP DEUR DIE MUNISIPALITEIT WINDHOEK.

The Administrator has been pleased under and by virtue of the powers in him vested by section 10 (d) of the Dairy Industry Control Ordinance, 1962 (Ordinance 29 of 1962), (hereinafter referred to as the ordinance), approve, with effect from the first day of July, 1966, the levy imposed by the Dairy Industry Control Board in terms of the said paragraph (d) on fresh milk purchased by the Windhoek Municipality as set out in the Schedule thereto.

Dit behaag die Administrateur om kragtens en ingevolge die bevoegdheid hom verleen by artikel 10 (d) van die Ordonnansie op die Beheer van die Suiwelnywerheid 1962 (Ordonnansie 29 van 1962) — hierna heet dit die ordonnansie — sy goedkeuring met ingang van die eerste dag van Julie 1966 te heg aan die heffing deur die Raad van Beheer oor die Suidwelnywerheid ingevolge die genoemde paragraaf (d) gelê op vars melk aangekoop deur die Munisipaliteit Windhoek, soos in die bylae hiervan uiteengesit.

BYLAE.

PRICES OF FACTORY CHEESE.

The Administrator has been pleased under and by virtue of the powers in him vested by section 10 (c) of the Dairy Industry Control Ordinance, 1962 (Ordinance 29 of 1962), hereinafter referred to as the Ordinance, to approve, with effect from the first day of July, 1966, the prices determined by the Dairy Industry Control Board in terms of the said paragraph (c) for factory cheese as set out in the schedule hereto.

Government Notice 114 of the 1st July, 1965, is hereby withdrawn.

The Dairy Industry Control Board has in terms of sections 10 and 12 of the Ordinance determined that as from the first day of July, 1966 —

(1) no factory cheese manufacturer shall sell factory cheese of the cheddar and sweet milk types at a price other than the fixed prices stated below at the places mentioned:
