## VERKIESING VAN 'N SENATOR.

NADEMAAL 'n vakature ontstaan het in die verteenwoordiging van die gebied Suidwes-Afrika in die Senaat weens die afsterwe van senator dr. H. J. Steyn;

SO IS DIT dat ek, kragtens die bevoegdheid my verleen by paragraaf (1) (a) van regulasie *vyf* van die regulasies vir die verkiesing van senatore in die gebied Suidwes-Afrika, uitgevaardig by Goewermentskennisgewing No. R. 1342 van 2 September 1960, hierby verklaar —

- (a) dat daar 'n vakature in die verteenwoordiging van die gebied Suidwes-Afrika in die Senaat bestaan;

## ELECTION OF A SENATOR.

WHEREAS a vacancy has occurred in the representation of the territory of South West Africa in the Senate by reason of the death of Senator Dr. H. J. Steyn;

NOW, THEREFORE, under and by virtue of the powers vested in me by paragraph (1) (a) of regulation *five* of the regulations for the election of senators in the territory of South West Africa, issued under Government Notice No. R. 1342 of the 2nd September, 1960, I do hereby declare —

- (a) that a vacancy exists in the representation of the territory of South West Africa in the Senate;
- (b) that Tuesday the eighth day of November, 1966, has been set down as the day on which a sitting of members of the House of Assembly and of the Legislative Assembly elected for the territory of South West Africa shall be held for the purpose of the election of a senator;
- (c) that the aforesaid sitting shall commence at 10 o'clock in the forenoon of the aforesaid day; and
- (d) that the council chamber of the said Legislative Assembly at Windhoek shall be the place at which
