- (i) under and by virtue of the provisions of section 2 of the Road Traffic Ordinance, 1967 (Ordinance 30 of 1967) — hereinafter referred to as the Ordinance — appointed the officers mentioned in column 1 as registering authorities for the purposes of the Ordinance for the areas mentioned in column 2 opposite each registering authority with local limits as defined in column 3; and
- (ii) under and by virtue of the provisions of section 7 of the Ordinance assigned to each registering authority the registration marks mentioned in column 4 opposite each registering authority.
