PERI-URBAN DEVELOPMENT BOARD: AMENDMENT OF EMPLOYEES REGULATIONS.

The Executive Committee has under and by virtue of the provisions of section 40 of the Peri-Urban Development Board Ordinance, 1970 (Ordinance 19 of 1970) further amended the regulations promulgated by Government Notice 163 of 1970 as amended by Government Notices 113 and 156 of 1971.

1. By substituting the following for paragraphs (a) and (b) of regulation 74 (1) —

“(a) To a white employee if his annual salary or wages, including pensionable allowances and the cash value of pensionable privileges granted in kind —

- (i) are higher than R5 400 — not exceeding R9,00 a day;
- (ii) are higher than R4 800 but not higher than R5 400 — not exceeding R8,00 a day;
- (iii) are equal to or lower than R4 800 — not exceeding R7,00 a day.

(b) In the case of a non-white employee if his annual wage, inclusive of pensionable allowances and the cash value of pensionable privileges provided in kind —

Not more than (R) per
 day for all
 non-whites —

- (i) is higher than R7 200 = R8,00 a day
- (ii) is higher than R4 800 but not not higher than R7 200 = R6,00 a day
- (iii) is higher than R3 600 but not higher than R4 800 = R4,50 a day
- (iv) R780 and higher but not higher than R3 600 = R3,25 a day
- (v) is lower than R780 = R2,00 a day”

2. By substituting the following for regulation 76 (2) —

“(2) Subsistence allowance at the following rates may be paid to an employee in respect of every hour of absence in excess of 24 hours or a multiple of 24 hours:

- “(i) maximum R9,00: not exceeding 38c per hour
- (ii) maximum R8,00: not exceeding 33c per hour
- (iii) maximum R7,00: not exceeding 29c per hour
- (iv) maximum R6,00: not exceeding 25c per hour
- (v) maximum R4,50: not exceeding 19c per hour
- (vi) maximum R3,25: not exceeding 14c per hour
- (vii) maximum R2,00: not exceeding 8c per hour”

HISTORIESE EN NATUURKUNDIGE BELANG.

Die Otjikoto-meer is 'n groot ronde sinkgat met regop dolomietkranse. Die watervlak bly feitlik konstant en daar word vermoed dat dit verband hou met onderaardse waterbronne en ander soortgelyke sinkgate in die nabyheid. Hierdie meer is reeds in 1851 deur reisigers Andersson en Galton besoek. In 1915 toe die Duitse „Schutztruppe” op die rand van oorgawe aan die Unietroep was, het hulle hul ammunisie in die Otjikoto-meer gegooi.

DECLARATION OF A NATIONAL MONUMENT.

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, Minister of National Education, hereby declare the area with the Otjikoto Lake thereon, near Tsumeb in South West Africa, to be a national monument.

DESCRIPTION.

The area represented by the figure A B C D E F G H J K with the Otjikoto Lake thereon, situate on the Remainder of Block 649, Registration Division „B”, being a portion of consolidated farm Tsumore 761 which at present is still an unregistered consolidation of the said Block 649 and other properties. This proposed area for proclamation is shown on a plan of the Tsumeb Corporation Limited, namely Plan 5-2-21, dated 3 April 1971 and filed at the offices of the Tsumeb Corporation and on File 12/S/T-b/1 of the National Monuments Council. Measuring as such: 2,8246 hectares.

HISTORICAL AND NATURAL INTEREST.

The Otjikoto Lake is a large circular sinkhole with vertical cliffs of dolomite. The water level remains virtually constant and it is presumed that this is connected with underground water sources and other similar sinkholes in the vicinity. As early as in 1851 this lake was visited by the travellers Andersson and Galton. In 1915 when the German „Schutztruppe” were on the point of surrender to the Union troops, they threw their ammunition in the Otjikoto Lake.

The third part of the paper is devoted to a discussion of the problem of finding the maximum value of the function $f(x)$ on the interval $(0, 1)$. It is shown that the maximum value of $f(x)$ is 1 and is attained at $x = 1/2$.

The fourth part of the paper is devoted to a discussion of the problem of finding the minimum value of the function $f(x)$ on the interval $(0, 1)$. It is shown that the minimum value of $f(x)$ is 0 and is attained at $x = 0$ and $x = 1$.

The fifth part of the paper is devoted to a discussion of the problem of finding the maximum value of the function $f(x)$ on the interval $(0, 1)$ for a general class of functions. It is shown that the maximum value of $f(x)$ is 1 and is attained at $x = 1/2$.
