**EDUCATION AMENDMENT ORDINANCE, 1973.**

(Assented to 5 July 1973.)

(Afrikaans text signed by the Administrator.)

(Date of commencement 1 January 1973.)

**ORDINANCE**

To amend the Education Ordinance, 1962, so as to substitute the expression "Executive Committee" for the word "Administrator"; to define the expression "Executive Committee"; and to amend the minimum time to be devoted to religious instruction in standard eight.

**BE IT ORDAINED** by die Legislative Assembly for the Territory of South West Africa as follows:—

1. The Education Ordinance, 1962 (Ordinance 27 of 1962) — hereinafter referred to as the principal Ordinance — is hereby amended by the substitution for the word "Administrator" wherever it appears of the expression "Executive Committee".

2. Section 2 of the principal Ordinance is hereby amended by the addition at the end thereof of the following definition:

"(xxxvi) "Executive Committee" means the Administrator-in-Executive Committee as referred to in section 6 of the South West Africa Constitution Act, 1968 (Act 39 of 1968).".

3. Section 78 of the principal Ordinance is hereby amended by the substitution for subsection (3) of the following subsection:

"(3) Instruction in terms of subsections (1) and (2) shall be given during school hours and at the time prescribed by the Director: Provided that the time devoted to such instruction shall be at least one and one half hours per week in every sub-standard, at least two and one half hours per week in every standard from standard one up to and including standard four, at least one and one half hours per week in every standard from standard five up to and including standard seven and at least one hour per week in every standard from standard eight up to and including standard ten.".

4. This Ordinance shall be called the Education Amendment Ordinance, 1973, and shall be deemed to have come into operation on the first day of January, 1973.

## ORDONNANSIE

Tot wysiging van die Onderwysordonnansie 1962 om die woord "Administrateur" deur die uitdrukking "Uitvoerende Komitee" te vervang; om die uitdrukking "Uitvoerende Komitee" te omskryf; en om die minimum onderrigtyd van godsdiensonderrig in standerd agt te wysig.

Die Wetgewende Vergadering van die Gebied Suidwes-Afrika VERORDEN SOOS VOLG:

1. Die Onderwysordonnansie 1962 (Ordonnansie 27 van 1962) — hieronder die Hoofordonnansie genoem — word hierby gewysig deur die woord "Administrateur" oral waar dit voorkom deur die uitdrukking "Uitvoerende Komitee" te vervang.

2. Artikel 2 van die Hoofordonnansie word hierby gewysig deur die volgendewoordomskrywing aan die einde daarvan by te voeg:

"(xxxvi) "Uitvoerende Komitee" die Administrateur-in-Uitvoerende Komitee soos bedoel in artikel 6 van die Wet op die Konstitusie van Suidwes-Afrika, 1968 (Wet 39 van 1968)."

3. Artikel 78 van die Hoofordonnansie word hierby gewysig deur subartikel (3) deur die volgende subartikel te vervang:

"(3) Onderrig kragtens subartikels (1) en (2) word gedurende skoolure gegee en op die tye wat die Direkteur voorskryf: Met dien verstande dat die onderrigtyd in elk van die substanders minstens een en 'n halfuur per week, in elke standerd van standerd een tot en met standerd vier minstens twee en 'n halfuur per week, in elke standerd van standerd vyf tot en met standerd sewe minstens een en 'n halfuur per week en in elke standerd van standerd agt tot en met standerd tien minstens een uur per week moet wees."

4. Hierdie Ordonnansie heet die Wysigingsordonnansie op Onderwys, 1973 en word geag op die eerste dag van Januarie 1973 in werking te getree het.
