BY THE HONOURABLE BAREND JOHANNES VAN DER WALT, ADMINISTRATOR OF SOUTH WEST AFRICA.

PROROGATION AND SUMMONING OF THE LEGISLATIVE ASSEMBLY.

Under and by virtue of the powers and authority vested in me by section 15(2) and (3) of the South West Africa Constitution Act, 1968 (Act 39 of 1968) of the Parliament of the Republic of South Africa, I hereby prorogue the Legislative Assembly for the Territory of South West Africa until Monday, 25 February 1974, and declare that the Fifth Session of the Tenth Legislative Assembly will commence at Windhoek at 2.30 p.m. on that day for the dispatch of business.
