GEKOSE KLEURLINGRAAD VAN SUIDWES-  
AFRIKA: AANSTELLING VAN AFBAKENINGS-  
KOMMISSIE.

ELECTED COLOURED COUNCIL FOR SOUTH  
WEST AFRICA: APPOINTMENT OF DELIMI-  
TATION COMMISSION.

Die Staatspresident het kragtens artikel 8(1) van die  
Ordonnansie op die Instelling van 'n Gekose  
Kleurlingraad van Suidwes-Afrika, 1966 (Ordonnansie  
29 van 1966), die Edelagbare Frans Hendrik  
Badenhorst, Regter-President van die Suidwes-Afrika-  
Afdeling van die Hoogeregshof van Suid-Afrika met in-  
gang van 7 Junie 1974, aangestel as 'n kommissie om  
kragtens artikel 8 van genoemde ordonnansie die af-  
bakening van die gebied Suidwes-Afrika in die  
kiesafdelings te onderneem.

The State President has, in terms of section 8(1) of the  
Establishment of an Elected Coloured Council for South  
West Africa Ordinance, 1966 (Ordinance 29 of 1966),  
appointed the Honourable Frans Hendrik Badenhorst,  
Judge President of the South West Africa Division of  
the Supreme Court of South Africa, with effect from the  
7th June 1974 to be a commission to undertake the  
delimitation of the territory of South West Africa into  
electoral division in terms of section 8 of the said or-  
dinance.

Mnr. W. W. Blomerus, Departement van Binnelandse  
Sake, Windhoek, is as sekretaris van gemelde kommissie  
aangestel.

Mr. W. W. Blomerus, Department of the Interior,  
Windhoek, has been appointed secretary of the said  
commission.
