### ORDINANCE, 1977: PROMULGATION OF

### ORDONNANSIE, 1977: UITVAARDIGING VAN

Dit behaag die Administrateur om sy goedkeuring te heg, ooreenkomstig artikel 27 van die Wet op die Konstitusie van Suidwes-Afrika, 1968 (Wet 39 van 1968), aan die volgende Ordonnansie wat hierby vir algemene inligting gepubliseer word ooreenkomstig artikel 29 van gemelde Wet:

## APPROPRIATION ORDINANCE, 1977

*(Assented to 26 May 1977)**(Afrikaans text signed by die Deputy Administrator)**(Date of commencement 30 May 1977)***ORDINANCE**

To apply a sum of money towards the service of the Territory of South West Africa for the financial year ending on the thirty-first day of March, 1978.

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa, with the consent of the State President, in so far as such consent is necessary, previously obtained and communicated to the Assembly by message from the Administrator, as follows:—

Territory Revenue Fund charged with R137 667 000 on Revenue Account.

1. The Territory Revenue Fund is hereby charged with such sums of moneys as may be required for the service of the Territory for the financial year ending on the thirty-first day of March, 1978, not exceeding in the aggregate one hundred and thirty seven million six hundred and sixty seven thousand rand on revenue account as shown in Column 1 of the Schedule.

How money is to be applied.

2. The money appropriated by this Ordinance shall be applied to the services detailed in the Schedule, and more particularly specified in the Estimates of Expenditure (S.W.A. 7-1977), as approved by the Legislative Assembly, and subject to section 3 hereof, and to no other purpose.

Administrator-in-Executive Committee may approve variation.

3. With the approval of the Administrator-in-Executive Committee a saving on any subhead of a vote may be made available to meet excess expenditure on any other subhead, or expenditure on a new subhead of the same vote: Provided that the sums appearing in Column 2 of the Schedule shall not be exceeded, nor shall savings thereon be available for any purpose other than that for which the money is hereby granted as indicated in the said Schedule.

Short title.

4. This Ordinance shall be called the Appropriation Ordinance, 1977.

Tot aanwending van 'n som geld ten behoeve van die diens van die Gebied Suidwes-Afrika vir die boekjaar wat op die een-en-dertigste dag van Maart 1978 eindig.

Die Wetgewende Vergadering van die Gebied Suidwes-Afrika, met die toestemming van die Staatspresident dermate sodanige toestemming nodig is vooraf verkry en deur boodskap van die Administrateur aan die Vergadering meegedeel, VERORDEN SOOS VOLG:—

1. Die Gebiedsinkomstefonds word hiermee belas met die somme geld wat nodig mag wees vir die diens van die Gebied vir die boekjaar wat op die een-en-dertigste dag van Maart 1978 eindig, maar gesamentlik hoogstens eenhonderd sewe-en-dertig miljoen seshonderd sewe-en-estigduisend rand op die inkomsterekening soos uiteengesit in Kolom 1 van die Bylae.

rekening.

2. Die geld wat deur hierdie Ordonnansie beskikbaar gestel word, moet aangewend word vir die dienste in besonderhede vermeld in die Bylae en meer omstandig uiteengesit in die Begroting van Uitgawes (S.W.A. 7-1977) soos deur die Wetgewende Vergadering goedgekeur, en behoudens artikel 3 hiervan, en vir geen ander doel nie.

3. Met die goedkeuring van die Administrateur-in-Uitvoerende Komitee kan 'n besparing onder die een subhoof van 'n begrotingspos aangewend word tot dekking van 'n oorskryding onder enige ander subhoof, of van uitgawe onder 'n nuwe subhoof van dieselfde begrotingspos: Met dien verstande dat die somme wat in Kolom 2 van die Bylae voorkom, nie oorskry mag word nie, en besparings daarop ewemin aangewend mag word vir enige ander doel as dié waarvoor die geld hierby toegestaan word soos in die gemelde Bylae aangedui.
