### BYLAE

### SCHEDULE

*Woordoms krywing*

*Definition*

1. (1) In hierdie Proklamasie beteken "Algemene Proklamasie" die Proklamasie op die Oordrag van Uitvoerende Gesag (Algemene Bepalings), 1977 (Proklamasie AG. 7 van 1977).

1. (1) In this Proclamation "General Proclamation" means the Executive Powers Transfer (General Provisions) Proclamation, 1977 (Proclamation AG. 7 of 1977).

(2) 'n Verwysing in hierdie Proklamasie na 'n bepaalde wet word uitgelê as 'n verwysing ook na 'n regulasie, reël of ander maatreël wat kragtens daardie wet gemaak is of daarop betrekking het.

(2) A reference in this Proclamation to any particular law shall be construed as a reference including a reference to a regulation, rule or other enactment made under or relating to that law.

*Oordrag van administrasie van Departement van Landbou-tegniese Dienste*

2. Ondanks andersluidende bepalings van enige ander wet maar behoudens die bepalings van hierdie Proklamasie en die Algemene Proklamasie, word die administrasie van die sake van die gebied Suidwes-Afrika met betrekking tot 'n aangeleentheid wat by die inwerkingtrede van hierdie Proklamasie deur die Minister van Landbou van die Republiek van Suid-Afrika in die Departement van Landbou-tegniese Dienste geadmistreer word, deur die Administrateur-generaal behartig.

*Toepassing van wette*

3. (1) Die bepalings van subartikel (1) van artikel 3 van die Algemene Proklamasie is, sonder om afbreuk te doen aan die bepalings van subartikel (2) van daardie artikel, nie van toepassing nie op —

- (a) die Veeartswet, 1933 (Wet 16 van 1933);
- (b) artikel 2 en die verwysing na Republiek in artikel 16(1) en (6)(a)(i) van die Wet op Misstowwe, Veevoedsel, Landboumiddels en Veemiddels, 1947 (Wet 36 van 1947);
- (c) die verwysing na Republiek in die Wet op Diersiektes en -parasiete, 1956 (Wet 13 van 1956), en die verwysing na die Minister van Landbou in artikel 23 daarvan;
- (d) die Wet op Veebrandmerke, 1962 (Wet 87 van 1962);
- (e) die verwysing na die Minister van Landbou in artikel 24 van die Grondbewaringswet, 1969 (Wet 76 van 1969);
- (f) die verwysing na die Minister van Landbou in artikel 15 van die Wet op Landbouplae, 1973 (Wet 3 van 1973);
- (g) artikel 23 van die Wysigingswet op Misstowwe, Veevoedsel, Landboumiddels en Veemiddels, 1977 (Wet 24 van 1977);
- (h) artikel 4(1), die verwysing na die Minister van Landbou in artikel 33, en artikel 38 van die Veeverbeteringswet, 1977 (Wet 25 van 1977).

(2) Die bepalings van subartikel (1)(c) van artikel 3 van die Algemene Proklamasie is, sonder om afbreuk te doen aan die bepalings van subartikel (2) van daardie artikel, nie van toepassing nie op die verwysing na Republiek in die Wet op Landbouplae, 1973, en die Veeverbeteringswet, 1977.

*Transfer of administration of Department of Agricultural Technical Services*

2. Notwithstanding anything to the contrary contained in any other law but subject to the provisions of this Proclamation and the General Proclamation, the administration of the affairs of the territory of South West Africa in relation to any matter which at the commencement of this Proclamation is administered by the Minister of Agriculture of the Republic of South Africa in the Department of Agricultural Technical Services, shall be carried on by the Administrator-General.

*Application of laws*

3. (1) The provisions of subsection (1) of section 3 of the General Proclamation shall, without detracting from the provisions of subsection (2) of that section, not apply to —

- (a) the Veterinary Act, 1933 (Act 16 of 1933);
- (b) section 2 and the reference to Republic in section 16(1) and (6)(a)(i) of the Fertilizers, Farm Feeds, Agricultural Remedies and Stock Remedies Act, 1947 (Act 36 of 1947);
- (c) the reference to Republic in the Animal Diseases and Parasites Act, 1956 (Act 13 of 1956), and the reference to the Minister of Agriculture in section 23 thereof;
- (d) the Livestock Brands Act, 1962 (Act 87 of 1962);
- (e) the reference to the Minister of Agriculture in section 24 of the Soil Conservation Act, 1969 (Act 76 of 1969);
- (f) the reference to the Minister of Agriculture in section 15 of the Agricultural Pests Act, 1973 (Act 3 of 1973);
- (g) section 23 of the Fertilizers, Farm Feeds, Agricultural Remedies and Stock Remedies Amendment Act, 1977 (Act 24 of 1977);
- (h) section 4(1), the reference to the Minister of Agriculture in section 33, and section 38 of the Livestock Improvement Act, 1977 (Act 25 of 1977).

(2) The provisions of subsection (1)(c) of section 3 of the General Proclamation shall, without detracting from the provisions of subsection (2) of that section, not apply to the reference to Republic in the Agricultural Pests Act, 1973, and the Livestock Improvement Act, 1977.

(3) Die bepalings van subartikel (1) van artikel 4 van die Algemene Proklamasie is nie van toepassing nie op artikel 32 van die Wet op Landbouplae, 1973.

*Kort titel*

4. Hierdie Proklamasie heet die Proklamasie op die Oordrag van Uitvoerende Gesag (Landbou-tegniese Dienste), 1978.

(3) The provisions of subsection (1) of section 4 of the General Proclamation shall not apply to section 32 of the Agricultural Pests Act, 1973.

*Short title*

4. This Proclamation shall be called the Executive Powers (Agricultural Technical Services) Transfer Proclamation, 1978.
