VERKLARING VAN EDWARD COOK SE GEDENKSTEEN TE WARMBAD TOT NASIONALE GEDENKWAARDIGHEID

DECLARATION OF EDWARD COOK'S COMMEMORATIVE STONE AT WARMBAD AS A NATIONAL MONUMENT

Kragtens artikel 10(1) van die Wet op Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969), verklaar ek hierby Edward Cook se gedenksteen, tesame met die hele terrein binne die bestaande klipmuur-omheining, asook die klipmuur self, te Warmbad, tot nasionale gedenkwaardigheid.

By virtue of the powers vested in me by section 10(1) of the National Monuments Act, 1969 (Act 28 of 1969), I hereby declare the commemorative stone of Edward Cook, together with the whole area within the existing stone-wall fence, as well as the stone-wall itself, at Warmbad, to be a national monument.

BESKRYWING

DESCRIPTION

Edward Cook se gedenksteen, tesame met die terrein binne die bestaande klipmuur-omheining, asook die klipmuur self, geleë op sekere Plaas Warmbad Dorpsgronde No. 145 in die Dorpsbestuurgebied Warmbad, Registrasie-afdeling V, gebied Suidwes-Afrika, en groot : Vier-en-twintigduisend negehonderd twee-en-tagtig (24 982) hektaar, Negeduisend eenhonderd sewe-en-sewentig (9 177) vierkante meter. Edward Cook's commemorative stone, together with the whole area within the existing stone-wall fence, as well as the stone-wall itself, situate on certain Farm Warmbad Townlands No. 145, situate in the Village Management Board Area of Warmbad, Registration Division V, territory of South West Africa, and measuring : Twenty-four thousand nine hundred and eighty-two (24 982) hectares, Nine thousand one hundred and seventy-seven (9 177) square metres. HISTORIESE EN ARGITEKTONIESE BELANG

HISTORICAL AND ARCHITECTURAL INTEREST

Hierdie gedenksteen is in 1929 opgerig ter nagedagtenis van die sendeling Edward Boyer Cook (1806-1843), stigter van Nisbett Bath (Warmbad), die eerste Wesleyaanse-sendingstasie in Groot Namakwaland. RNG 10/2/561.
