

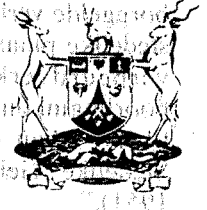

*Wysiging van Bylae by Proklamasie R.323 van 22 Desember 1972, soos gewysig deur Proklamasie AG. 5 van 1977*

1. Die Bylae by Proklamasie R.323 van 22 Desember 1972 van die Staatspresident van die Republiek van Suid-Afrika word hierby gewysig deur die volgende subregulasie by regulasie 13 te voeg:

" (3) Enige boete opgelê en borggelde verbeurd verklaar ten opsigte van 'n oortreding van hierdie regulasies word na invordering daarvan, ondanks andersluidende bepalings van die een of ander wet,

AMENDMENT OF REGULATIONS FOR THE ESTABLISHMENT OF EMPLOYMENT BUREAUX IN THE TERRITORY OF SOUTH WEST AFRICA

### SCHEDULE

*Amendment of Schedule to Proclamation R.323 of 22 December 1972, as amended by Proclamation AG. 5 of 1977.*

1. The Schedule to Proclamation R.323 of 22 December 1972 of the State President of the Republic of South Africa is hereby amended by the addition of the following subregulation to regulation 13:

" (3) Any fine imposed, and any moneys es-timated as bail, in respect of any contravention of these regulations shall, when recovered, notwithstanding anything to the contrary contained in

“ (4) Enige boete opgelê en borggelde verbeurd verklaar ten opsigte van ’n oortreding van hierdie regulasies word, na invordering daarvan, ondanks andersluidende bepalings van die een of ander wet, oorbetaal aan die stedelike plaaslike bestuur wat die werkverskaffingsburo behartig in wie se regsgebied die oortreding gepleeg word ten opsigte waarvan daardie boete opgelê word of daardie borggeld verbeurd verklaar word, en die betrokke stedelike plaaslike bestuur stort sodanige boete of verbeurdverklaarde borggelde in sy Inboorlinginkomsterekening ingestel kragtens artikel 17 van die Proklamasie op Inboorlinge in Stedelike Gebiede, 1951 (Proklamasie 56 van 1951).”.

2. The Schedule to Proclamation R.32 of 9 February 1973 of the State President of the Republic of South Africa is hereby amended by the addition of the following subregulation to regulation 13:

“ (4) Any fine imposed, and any moneys estreated as bail, in respect of any contravention of these regulations shall, when recovered, notwithstanding anything to the contrary contained in any other law, be paid to the urban local authority conducting the employment bureau in whose area of jurisdiction the contravention in respect of which that fine is imposed or that money is estreated as bail, is committed, and the urban local authority concerned shall pay such fine or moneys estreated as bail into its native revenue account opened under section 17 of the Natives (Urban Areas) Proclamation, 1951 (Proclamation 56 of 1951).”.

*Short title*

3. This Proclamation shall be called the Employment Bureaux Amendment Proclamation, 1978.
