

ORDONNANSIE, 1978: UITVAARDIGING VAN

ORDINANCE, 1978: PROMULGATION OF

Die Administreer-generaal het, ingevolge artikel 27 van die Wet op die Konstitusie van Suidwes-Afrika, 1968 (Wet 39 van 1968), tot die volgende Ordonnansie toegestem wat hierby vir algemene inligting gepubliseer word ingevolge artikel 29 van genoemde Wet:

The Administrator-General has assented, in terms of section 27 of the South West Africa Constitution Act, 1968 (Act 39 of 1968), to the following Ordinance which is hereby published for general information in terms of section 29 of the said Act:—

ORDONNANSIE

Tot wysiging van die Ordonnansie op die Raad vir Buitestedelike Ontwikkeling, 1970, om voorsiening te maak vir die verklaring van 'n gebied ten opsigte waarvan die raad van 'n munisipaliteit wat afgeskaf is, regsbevoegdheid uitgeoefen het, tot 'n buitestedelike gebied; en om vir bykomstige aangeleenthede voorsiening te maak.

Die Wetgewende Vergadering van die Gebied Suidwes-Afrika VERORDEN SOOS VOLG:—

Vervanging van artikel 36 van Ordonnansie 19 van 1970.

1. Artikel 36 van die Ordonnansie op die Raad vir Buitestedelike Ontwikkeling, 1970, word hierby deur die volgende artikel vervang:

"Verklaring van munisipale gebied of dorpsbestuursgebied tot buitestedelike gebied."

36. (1) Indien —

- (a) 'n munisipaliteit gestig of ingestel of beskou as gestig of ingestel ingevolge die Munisipale Ordonnansie 1963 (Ordonnansie 13 van 1963); of
- (b) 'n dorpsbestuursgebied tot sodanig verklaar of beskou as tot sodanig verklaar ingevolge die Ordonnansie op Dorpsbesture 1963 (Ordonnansie 14 van 1963),

deur die Uitvoerende Komitee by proklamasie in die *Offisiële Koerant* afgeskaf word, kan die Uitvoerende Komitee in dieselfde proklamasie die gebied —

- (i) ten opsigte waarvan die raad van bedoelde munisipaliteit regsbevoegdheid uitgeoefen het; of
 - (ii) wat aldus tot 'n dorpsbestuursgebied verklaar was of beskou is as tot 'n dorpsbestuursgebied verklaar te gewees het,
- na gelang van die geval, met ingang van die datum van sodanige afskaffing verklaar tot 'n buitestedelike gebied waarop hierdie ordonnansie van toepassing is.

PERI-URBAN DEVELOPMENT BOARD No. 7 of 1978
AMENDMENT ORDINANCE, 1978

(Assented to 2 June 1978)

(Date of commencement 5 June 1978)

ORDINANCE

To amend the Peri-Urban Development Board Ordinance, 1970, so as to provide for a declaration that an area in respect of which the council of a municipality which has been abolished, had exercised jurisdiction, shall be a peri-urban area; and to provide for incidental matters.

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa, as follows:—

1. The following section is hereby substituted for section 36 of the Peri-Urban Development Board Ordinance, 1970 (Ordinance 19 of 1970):

Substitution of section 36 of Ordinance 19 of 1970.

"Declaration of a municipal area or Village Management Board Area to be a peri-urban area.

36. (1) Whenever —

- (a) any municipality established or constituted or deemed to have been established or constituted in terms of the Municipal Ordinance, 1963 (Ordinance 13 of 1963); or
- (b) any Village Management Board Area declared as such or deemed to have been so declared in terms of the Village Management Boards Ordinance, 1963 (Ordinance 14 of 1963),

is abolished by the Executive Committee by proclamation in the *Official Gazette* the Executive Committee may in the same proclamation declare that the area —

- (i) in respect of which the council of the said municipality exercised jurisdiction; or
- (ii) which had been so declared to be, or deemed to have been so declared to be a Village Management Board Area,

as the case may be, shall, with effect from the date of such abolition, be a peri-urban area to which this ordinance is applicable.

(2) Al die bate en laste, regte en verpligtinge van —

(a) 'n munisipaliteit wat aldus afgeskaf is;

(b) 'n dorpsbestuur wat ingestel was vir 'n dorpsbestuursgebied wat aldus afgeskaf is,

gaan met ingang van die datum bedoel in subartikel (1) oor op die raad en word met ingang van bedoelde datum bate en laste, regte en verpligtinge van die raad ten opsigte van die aldus verklaarde buitestedelike gebied.

(3) Alle regulasies gemaak deur —

(a) die raad van 'n munisipaliteit wat aldus afgeskaf is;

(b) 'n dorpsbestuur wat ingestel was vir 'n dorpsbestuursgebied wat aldus afgeskaf is, bly in en vir die gebied wat aldus tot 'n buitestedelike gebied verklaar is van krag en van toepassing totdat hulle ooreenkomsdig hierdie ordonnansie herroep of gewysig word.”.

Kort titel.

2. Hierdie Ordonnansie heet die Wysigingsordonnansie op die Raad vir Buitestedelike Ontwikkeling, 1978.

PERI-URBAN DEVELOPMENT BOARD No. 7 of 1978
AMENDMENT ORDINANCE, 1978

(2) All the assets and liabilities, rights and obligations of —

- (a) any municipality which has been so abolished;
- (b) any Village Management Board established for any Village Management Board Area which has been so abolished;

shall, with effect from the date referred to in subsection (1), pass to the board, and shall, with effect from the said date, become assets and liabilities, rights and obligations of the council in respect of the peri-urban area so declared.

(3) All regulations made by —

- (a) the council of any municipality which has been so abolished;
- (b) any Village Management Board which had been established for any Village Management Board Area which has been so abolished,

shall continue to be of force and effect in and for the area which has been so declared to be a peri-urban area until rescinded or amended in terms of this ordinance.”.

2. This Ordinance shall be called the Peri-Urban Development Board Amendment Ordinance, 1978. Short title.
