Wysiging van Bylae by Proklamasie R.65 van 1976

AMENDMENT OF REGULATIONS FOR ESTABLISHMENT OF EMPLOYMENT BUREAUX FOR NAMAS IN NAMALAND

SCHEDULE

Amendment of Schedule to Proclamation R.65 of 1976

1. The Schedule to Proclamation R.65 of 30 April 1976 of the State President of the Republic of South Africa is hereby amended by the addition of the following subregulation to regulation 26:

“ (4) Any fine imposed, and any moneys estreated as bail, in respect of any contravention of these regulations shall, when recovered, notwithstanding anything to the contrary contained in any other law, be paid to the Nama Commissioner appointed under Proclamation 160 of 11 July 1975, and the Nama Commissioner shall pay such fine or moneys estreated as bail in the Revenue fund, opened under sec-

2. This Proclamation shall be called the Second Employment Bureaux Amendment Proclamation, 1978.
