AMENDMENT OF REGULATIONS MADE
UNDER THE REGISTRATION OF DEEDS IN
REHOBOTH ACT, 1976 (ACT 93 OF 1976)

Die Administrateur-generaal het kragtens artikel 56
in die Wet op die Registrasie van Aktes in Rehoboth,
1976 (Wet 93 van 1976), die volgende regulasie
uitgevaardig:

The Administrator-General has under section 56 of
the Registration of Deeds in Rehoboth Act, 1976 (Act
93 of 1976), made the following regulation:

Regulasie 40 van die regulasies in die *Staatskoerant*
gekondig by Goewermentskennisgewing R2372 van 3
Desember 1976 word hierby gewysig deur die volgende
oorbehoudbepaling by subregulasie (1) te voeg:

Regulation 40 of the regulations published in the
Government Gazette under Government Notice R2372
of 3 December 1976 is hereby amended by the addition
to subregulation (1) of the following proviso:

“Met dien verstande dat geen bedrag gehef word nie
ten opsigte van ’n oordrag van grond wat voor 26
November 1976 deur die landdros goedgekeur is en
ten opsigte waarvan ’n aantekening in die registers
van die Kantoor van die Rehoboth-Bastergemeente
voorkom.”

“Provided that no fee shall be charged in respect of a
transfer of land approved by the magistrate before 26
November 1976, in respect of which an entry appears
in the registers of the office of the Rehoboth Baster
Community.”
