**AMENDMENT OF REGULATIONS RELATING  
TO THE CONTROL OF THE MEAT TRADE**

The Administrator-General has, under the powers vested in him by section 9 of the Meat Trade Control

Vleishandelbeheerordinansie, 1962 (Ordonnansie 20 van 1962), die regulasies vervat in die Bylae uitgevaardig.

## BYLAE

*Wysiging van regulasie 13 afgekondig by Goewermentskennisgewing 87 van 1963, soos gewysig deur regulasie 4 afgekondig by Goewermentskennisgewing 114 van 1 Augustus 1964*

1. Regulasie 13 afgekondig by Goewermentskennisgewing 87 van 1 Junie 1963 (hieronder die Vleishandelbeheerregulasies genoem), word hierby gewysig deur paragraaf (a) deur die volgende paragraaf te vervang:

“(a) Geen lewende hawe word uitgevoer voordat die bedrag verskuldig ten opsigte van die heffings of spesiale heffings bedoel in artikel 6 van die Vleishandelbeheerordinansie, 1962 (Ordonnansie 20 van 1962), betaal is nie.”.

*Herroeping van regulasie 14 afgekondig by Goewermentskennisgewing 87 van 1963, soos vervang deur regulasie 2 afgekondig by Goewermentskennisgewing R.694 van 29 April 1977*

2. Regulasie 14 van die Vleishandelbeheerregulasies word hierby herroep.

*Vervanging van regulasie 15 afgekondig by Goewermentskennisgewing 87 van 1963, soos gewysig deur regulasie 9 afgekondig by Goewermentskennisgewing 114 van 1 Augustus 1964*

3. Regulasie 15 van die Vleishandelbeheer regulasies word hierby deur die volgende regulasie vervang:

*“Indiening van opgawes en betaling van heffings en spesiale heffings”*

15. (1) Iemand wat lewende hawe in die Gebied vir plaaslike verbruik slag of wat lewende hawe uit die Gebied uitvoer moet die heffings en spesiale heffings deur die raad kragtens artikel 6 van die Vleishandelbeheerordinansie, 1962, opgelê, betaal.

(2) Iemand bedoel in subregulasie (1) moet voor of op die sewende dag van elke maand 'n opgawe (Vorm B) by die raad indien tesame met 'n bedrag wat hy kragtens subregulasie (1) verskuldig is.

(3) Indien die heffings en spesiale heffings bedoel in subregulasie (1) nie aldus betaal word nie, kan die slag van lewende hawe deur die Raad verbied word.

(4) 'n Beampte van die Raad kan te eniger tyd 'n abattoir of ander slagsplek of die boeke van 'n slagter ondersoek ten einde die juistheid te bepaal van die opgawe in subregulasie (2) bedoel.”.

Ordinance, 1962 (Ordinance 20 of 1962), made the regulations set out in the Schedule.

1. Regulation 13 published by Government Notice 87 of 1 June 1963 (hereinafter referred to as the Meat Trade Control Regulations), is hereby amended by the substitution for paragraph (a) of the following paragraph:

“(a) No livestock shall be exported until the amount due in respect of the levies and special levies referred to in section 6 of the Meat Trade Control Ordinance, 1962 (Ordinance 20 of 1962), has been paid.”.

*Repeal of regulation 14 published by Government Notice 87 of 1963, as substituted by regulation 2 published by Government Notice R.694 of 29 April 1977*

2. Regulation 14 of the Meat Trade Control Regulations is hereby repealed.

*Substitution of regulation 15 published by Government Notice 87 of 1963, as amended by regulation 9 published by Government Notice 114 of 1 August 1964*

3. The following regulation is hereby substituted for regulation 15 of the Meat Trade Control Regulations:

*“Rendering of returns and payment of levies and special levies”*

15. (1) Any person slaughtering livestock in the Territory for the purpose of local consumption or exporting livestock from the Territory, shall pay the levies and special levies imposed by the Board under section 6 of the Meat Trade Control Ordinance, 1962.

(2) Any person referred to in subregulation (1) shall, before or on the seventh day of each month render to the Board a return (Form B) together with an amount due by him under subregulation (1).

(3) If the levies and special levies referred to in subregulation (1) are not so paid, the Board may prohibit the slaughtering of livestock.

(4) Any officer of the Board may at any time inspect any abattoir or other slaughtering place or the books of a butcher with a view to determining the correctness of the return referred to in subregulation (2).”.
