Under the powers vested in me by section 53(2) of Proclamation R.117 of 1977 (establishment and management of townships in certain native areas in South West Africa), I hereby prescribe the following selling prices for sites in any township defined and set apart under section 3(1) of the said Proclamation, which is situated in Owambo or Kavango —
