Kragtens artikel 29 van die Grondwetgewende Vergadering- en Verkiesingsproklamasie, 1978 (Proklamasie AG. 63 van 1978), verklaar ek hierby—

(b) dat die stemming ten opsigte van die verkiesing vir 'n Grondwetgewende Vergadering ingevolge die bepalings van daardie Proklamasie, op 20, 21, 22, 23 en 24 November 1978 plaasvind en, behoudens genoemde bepalings, op elk van daardie dae om 07h00 'n aanvang neem en om 19h00 sluit.

ELECTION FOR A CONSTITUENT ASSEMBLY:
FIXING OF DAY AND PLACE FOR SESSION OF
REGISTRATION COURT, AND OF DAYS AND
HOURS FOR TAKING OF POLL

Under section 29 of the Constituent Assembly and Election Proclamation, 1978 (Proclamation AG. 63 of 1978), I hereby declare—

(a) that a registration court will sit on 11 October 1978 from 10h00 to 11h00 in the Regional Court-room, Magistrate's Office, Lüderitz Street, Windhoek, to receive the registration documents of political organizations desiring to register for election as contemplated in section 30 of that Proclamation; and

(b) that the poll in respect of the election for a Constituent Assembly in terms of the provisions of that Proclamation shall be taken on 20, 21, 22, 23 and 24 November 1978 and shall, subject to the said provisions, commence at 07h00 and close at 19h00 on each of those days.
