ORDER UNDER SECURITY DISTRICTS
PROCLAMATION, 1977, IN RELATION TO
MOVEMENT OF PERSONS IN OWAMBO

BEVEL KRAGTENS PROKLAMASIE OP VEILIG-
HEIDSDISTRIKTE, 1977, MET BETREKKING
TOT BEWEGING VAN PERSONE IN OWAMBO

Under the powers vested in me by section 3 of the Security Districts Proclamation, 1977 (Proclamation AG. 9 of 1977), I hereby order that no person shall be at any place in the district of Owambo outside the boundary of a stand, lot or site or other place intended or normally used for human habitation, at any time during the night without the permission in writing of a peace officer, as defined in section 1 of the Criminal Procedure Act, 1977 (Act 51 of 1977), or any officer of the security forces.

Kragtens die bevoegdheid my verleen by artikel 3 van die Proklamasie op Veiligheidsdistrikte, 1977 (Proklamasie AG. 9 van 1977), beveel ek hierby dat niemand te eniger tyd gedurende die nag op enige plek in die distrik Owambo buite die grens van 'n erf, perseel of terrein of ander plek wat bestem is of normaalweg gebruik word as woonplek vir mense, te wees nie sonder die skriftelike toestemming van 'n vredesbeampte, soos omskryf in artikel 1 van die Strafproseswet, 1977 (Wet 51 van 1977), of 'n offisier van die veiligheidsmagte.
