## SCHEDULE

*Amendment of section 1 of Act 4 of 1979 of the National Assembly*

1. Section 1 of the Functions of Directorates Act, 1979, is hereby amended —

(a) by the substitution for the definition of "department" of the following definition:

## BYLAE

*Wysiging van artikel 1 van Wet 4 van 1979 van die Nasionale Vergadering*

1. Artikel 1 van die Wet op die Funksies van Direktrate, 1979, word hierby gewysig —

(a) deur die omskrywing van "departement" deur die volgende omskrywing te vervang:

“‘department’ means a department as defined in the Public Service Act, 1957 (Act 54 of 1957), and includes the Department of Posts and Telecommunications referred to in the Post Office Act, 1958 (Act 44 of 1958);” and

(b) by the substitution for the definition of “head” of the following definition:

“‘head’, in relation to a department, means the head of such department in terms of the Public Service Act, 1957, or, as the case may be, the Postmaster-General referred to in the Post Office Service Act, 1974 (Act 66 of 1974);”.

“‘departement’ ’n departement soos omskryf in die Staatsdienswet, 1957 (Wet 54 van 1957), en ook die Departement van Pos- en Telekommunikasiewese in die Poswet, 1958 (Wet 44 van 1958), bedoel;” en

(b) deur die omskrywing van “hoof” deur die volgende omskrywing te vervang:

“‘hoof’, met betrekking tot ’n departement, die hoof van daardie departement ingevolge die Staatsdienswet, 1957, of, na gelang van die geval, die Posmeester-generaal in die Poskantoor-dienswet, 1974 (Wet 66 van 1974), bedoel;”.

**Short title and commencement**

2. This Proclamation shall be called the Functions of Directorates Amendment Proclamation, 1979, and shall come into operation on 1 December 1979.

**Kort titel en inwerkingtreding**

2. Hierdie Proklamasie heet die Wysigingsproklamasie op die Funksies van Direkorate, 1979, en tree op 1 Desember 1979 in werking.
