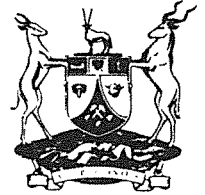

**Act No. 17, 1979 SECOND ADDITIONAL APPROPRIATION ACT,
1979**

ACT

**To appropriate an additional amount of money for the re-
quirements of the State in respect of the territory of South
West Africa during the financial year ending 31 March
1980.**

BE IT ENACTED by the National Assembly of South
West Africa, as follows:—

Appropriation of addi-
tional amount of money for
requirements of State.

1. Subject to the provisions of the Exchequer and Audit
Act, 1975 (Act 66 of 1975), there is hereby appropriated for
the requirements of the State in respect of the territory of
South West Africa as a charge to the Central Revenue
Fund, the additional amounts of money shown in column 1
of the Schedule.

Short title.

2. This Act shall be called the Second Additional Ap-
propriation Act, 1979.
