DEDUCTION TABLES: EMPLOYEES' AND  
PROVISIONAL TAX

I, JOHAN JONES, Director of Finance, acting by virtue of the power conferred on me under Section 3 of the Income Tax Ordinance, 1974 (Ordinance 5 of 1974), do hereby prescribe the following tax tables:

**1. EMPLOYEES' TAX:**

In terms of paragraph 9(1) of Schedule 3 of the said Ordinance, the employees' tax tables (identified as PAYE 10, Volume 3) for use by employers as defined in paragraph 1 of the Schedule.

**2. PROVISIONAL TAX:**

In terms of paragraph 17(5) of Schedule 3 of the said Ordinance, the tax tables (identified as PAYE 12, Volume 3) for optional use by provisional taxpayers.

Die belastingtabelle, geïdentifiseer as L.B.S. 10, Volume 2 en L.B.S. 12, Volume 2 word hiermee ingetrek met ingang vanaf 1 Maart 1980 en die nuwe belastingtabelle, geïdentifiseer as L.B.S. 10, Volume 3 en L.B.S. 12, Volume 3 tree in werking op 1 Maart 1980 en bly van krag tot nadere kennisgewing.

Geregistreeerde werkgewers en voorlopige belastingpligtiges moet die belastingtabelle vanaf 1 Maart 1980 by die kantoor van die Adjunk-Direkteur: Staatsinkomste, Privaatsak 13185, Windhoek, 9000 verkry.

The tax tables, identified as PAYE 10, Volume 2 and PAYE 12, Volume 2 are hereby withdrawn with effect from 1 March 1980 and the new tax tables, identified as PAYE 10, Volume 3 and PAYE 12, Volume 3 shall come into force on 1 March 1980 and shall remain in force until further notice.

Registered employers and provisional taxpayers must obtain the tax tables from the office of the Deputy Director: State Revenue, Private Bag 13185, Windhoek, 9000 as from 1 March 1980.
