AFKONDIGING VAN WET VAN NASIONALE VERGADERING

PROMULGATION OF ACT OF NATIONAL ASSEMBLY

Die volgende Wet, wat ingevolge die Proklamasie op die Nasionale Vergadering, 1979 (Proklamasie AG. 21 van 1979), deur die Nasionale Vergadering van Suidwes-Afrika aangeneem en deur die Administrateur-generaal onderteken is, word hierby afkondig ingevolge artikel 19 van daardie Proklamasie:

The following Act, which has been adopted by the National Assembly of South West Africa and signed by the Administrator-General in terms of the National Assembly Proclamation, 1979 (Proclamation AG. 21 of 1979) is hereby published in terms of section 19 of that Proclamation:

WYSIGINGSWET OP IDENTIFIKASIE VAN PERSONE, 1980*(Engelse teks deur die Administrateur-generaal onderteken op 15 April 1980)***DAAR WORD BEPAAL WET**

Tot wysiging van die Wet op Identifikasie van Persone, 1979, ten einde die omskrywing van "identiteitsdokument" te wysig en om vir vrystelling van inkomstebelasting van sekere besoldiging of toelaes en vir bykomstige aangeleenthede voorsiening te maak.

DAAR WORD BEPAAL deur die Nasionale Vergadering van Suidwes-Afrika, soos volg:

1. Artikel 1 van die Wet op Identifikasie van Persone, 1979 (hieronder die Hoofwet genoem), word hierby gewysig deur die volgende paragraaf by die omskrywing van "identiteitsdokument" te voeg:

"(d) met betrekking tot 'n persoon wat in die gebied gebore is maar nie gewoonlik daarin woonagtig is nie, ook die een of ander dokument in paragraaf (b) vermeld;".

2. Die volgende artikel word ná artikel 10 van die Hoofwet ingevoeg:

"10bis. Enige besoldiging of toelae wat ter bereiking van die oogmerke van hierdie Wet betaal is of staan te word –

(a) aan 'n persoon wat nie in die voltydse diens van die Staat is nie; of

(b) aan 'n persoon benewens sy besoldiging of toelae as 'n persoon in die voltydse diens van die Staat,

word by die toepassing van 'n wet wat 'n belasting op inkomste hef, nie as inkomste beskou nie.".

3. Hierdie Wet heet die Wysigingswet op Identifikasie van Persone, 1980.

IDENTIFICATION OF PERSONS ACT, 1980**Act No. 5, 1980**

*(English text signed by the Administrator-General on
15 April 1980)*

ACT

To amend the Identification of Persons Act, 1979, so as to amend the definition of "identity document" and to provide for exemption from income tax of certain remuneration or allowances and for incidental matters.

BE IT ENACTED by the National Assembly of South West Africa, as follows:—

1. Section 1 of the Identification of Persons Act, 1979 (hereinafter referred to as the principal Act), is hereby amended by the addition of the following paragraph to the definition of "identity document":

Amendment of section 1 of
Act 2 of 1979.

"(d) in relation to any person born in but nor ordinarily resident in the territory, also any document specified in paragraph (b);".

2. The following section is hereby inserted in the principal Act after section 10:

Insertion of section 10bis
in Act 2 of 1979.

"10bis. Any remuneration or allowance paid or to be paid for the purpose of achieving the objects of this Act —

- (a) to any person not in the full-time employment of the State; or
- (b) to any person in addition to his salary or allowance as a person in the full-time employment of the State,

shall, for the purposes of any law imposing any tax on income, not be regarded as income.".

3. This Act shall be called the Identification of Persons Short title.
